What does the Diocese look like:

The Catholic Diocese of Arundel and Brighton extends across four Local Authorities: Brighton & Hove; East Sussex; West Sussex and most of Surrey. The Diocese encompasses rural villages; coastal towns; urban cities, and everything in between. Our schools are located throughout the Diocese, from Englefield Green in north-west Surrey down to Chichester in West Sussex; across to Hastings in East Sussex, and up to Caterham in the east of Surrey.

How many schools are there?

There are 80 Catholic schools in the Diocese, comprising of 11 Secondary, 53 Primary, 15 Independent and 1 specialist school. There are 2 Catholic Education Trusts (CETs), Xavier in Surrey and Bosco in East and West Sussex. Some of our schools are academy schools within these two trusts.



What does it mean to be a school governor?

Foundation Governors agree

- to ensure that your school is conducted in accordance with the Trust Deed,
- to know and implement the Bishop's policies on education, and
- to understand and promote the distinctive nature of Catholic education.

They are therefore responsible for understanding, maintaining and developing **the distinctive nature of the Catholic school** within the Church's mission of education and in awareness of the contribution the Church makes to society through this mission.

All governors are able to contribute their rich experience, values and views to enhance and promote the school's ethos and vision. Real and exciting opportunities exist for regular discussion and debate across numerous aspects of school life and provision.

Being a governor affords you the opportunity of collaborating with a wide range of colleagues to ensure all children and young people receive enjoyable and developmental learning experiences **within a Christ-centred environment.** The governing body plays a key strategic role in the direction of and accountability for the school, but is also part of a network of relationships which includes children and young people, parents, staff, priests, religious, the Diocese, Local Authority, DfE, and the wider community.

How does the Diocesan Education Service support schools?

In the Diocese of Arundel & Brighton, the Education Service is responsible for offering training as well as support and care to Catholic Schools in the Diocese in both the maintained and independent sectors. The Education Service also liaises with Local Authorities throughout the Diocese and the Catholic Education Service based in London.



Types of Governor

Foundation Governors

Foundation Governors in voluntary aided and Academy Catholic schools are appointed by the Bishop as his representatives on the Governing Body.

They ensure that the school preserves its particular religious character and that it is conducted in accordance with the terms of the school's trust deed. Foundation Governors are appointed for a term of four years.
