Defined Terms

The terms "we," "us," and "our" refer to uFinancial Group. The terms "you" and "your" refer to you the user.

Scope of this Privacy Policy

This Privacy Policy applies to personal data submitted to, or collected by us through this website ufinancial group.com (the "Website"), various information request forms, and any and all correspondence by any means with uFinancial Group.

Information We Collect

We collect personal information about you when you register to use our services, and/or provide contact information to us via telephone, email, facsimile, mail, written correspondence, or through the Website. The information you consent to provide may include your email, year of birth, reason for enrolling, IP address, country in which you reside, and your reviews and opinions about our services.

Technical, Usage, and Location Information

We automatically collect information on how you interact with the Website, such as the IP address from which you access the Website, date and time, information about your browser, operating system and computer or device, and pages viewed and items clicked. We may also collect location information, including location information automatically provided by your computer or device. We use cookies and similar technologies to collect some of this information.

Third Party Platforms

This may include information such as "likes", follows, mentions, comments, and messages, profile information gathered from social networking sites, or the fact that you viewed or interacted with our content.

Google Analytics

Google Analytics is a web analytics service offered by Google that tracks and reports website traffic. Google uses the data collected to track and monitor the use of our Service. This data is shared with other Google services. Google may use the collected data to contextualize and personalize the ads of its own advertising network.
