## Algebra 1 – Math CCSS –Algebra (A)

| <p><b>Seeing Structure in Expressions</b><br/> <b>A.SSE.1</b> Interpret expressions that represent a quantity in terms of its context. ★<br/>           a. Interpret parts of an expression, such as terms, factors, and coefficients.<br/>           b. Interpret complicated expressions by viewing one or more of their parts as a single entity. <i>For example, interpret <math>P(1+r)^n</math> as the product of <math>P</math> and a factor not depending on <math>P</math>.</i><br/> <b>Fluency Recommendation</b></p> | <p><b>Seeing Structure in Expressions</b><br/> <b>A.SSE.3</b> Choose and produce an equivalent form of an expression to reveal and explain properties of the quantity represented by the expression. ★<br/>           a. Factor a quadratic expression to reveal the zeros of the function it defines.<br/>           b. Complete the square in a quadratic expression to reveal the maximum or minimum value of the function it defines.<br/>           c. Use the properties of exponents to transform expressions for exponential functions. <i>For example the expression <math>1.15t</math> can be rewritten as <math>(1.151/12)12t \approx 1.01212t</math> to reveal the approximate equivalent monthly interest rate if the annual rate is 15%.</i></p> | <p><b>Arithmetic with Polynomials and Rational Expressions</b><br/> <b>A.APR.1</b> Understand that polynomials form a system analogous to the integers, namely, they are closed under the operations of addition, subtraction, and multiplication; add, subtract, and multiply polynomials.<br/><br/> <b>Fluency Recommendation</b></p> | <p><b>Creating Equations★</b><br/> <b>A.CED.1</b> Create equations and inequalities in one variable and use them to solve problems. <i>Include equations arising from linear and quadratic functions, and simple rational and exponential functions.</i></p> |
| <p><b>Seeing Structure in Expressions</b><br/> <b>A.SSE.2</b> Use the structure of an expression to identify ways to rewrite it. <i>For example, see <math>x^4 - y^4</math> as <math>(x^2)^2 - (y^2)^2</math>, thus recognizing it as a difference of squares that can be factored as <math>(x^2 - y^2)(x^2 + y^2)</math>.</i></p>   |  | <p><b>Arithmetic with Polynomials and Rational Expressions</b><br/> <b>A.APR.3</b> Identify zeros of polynomials when suitable factorizations are available, and use the zeros to construct a rough graph of the function defined by the polynomial.</p>  | <p><b>Creating Equations★</b><br/> <b>A.CED.2</b> Create equations in two or more variables to represent relationships between quantities; graph equations on coordinate axes with labels and scales.</p>  |
| <p><b>Creating Equations★</b><br/> <b>A.CED.3</b> Represent constraints by equations or inequalities, and by systems of equations and/or inequalities, and interpret solutions as viable or nonviable options in a modeling context. <i>For example, represent inequalities describing nutritional and cost constraints on combinations of different foods.</i></p>  | <p><b>Creating Equations★</b><br/> <b>A.CED.4</b> Rearrange formulas to highlight a quantity of interest, using the same reasoning as in solving equations. <i>For example, rearrange Ohm's law <math>V = IR</math> to highlight resistance <math>R</math>.</i></p>  | <p><b>Reasoning with Equations and Inequalities</b><br/> <b>A.REI.1</b> Explain each step in solving a simple equation as following from the equality of numbers asserted at the previous step, starting from the assumption that the original equation has a solution. Construct a viable argument to justify a solution method.</p>   | <p><b>Reasoning with Equations and Inequalities</b><br/> <b>A.REI.3</b> Solve linear equations and inequalities in one variable, including equations with coefficients represented by letters.</p>   |
