  - a. **Vote by Proxy:** noteholders can grant a proxy to the noteholders' Agent. The noteholders' Agent will then vote according to the noteholder's instructions during the Voting Period. Noteholders must submit to the Agent **at any time from now until the end of the Voting Period:**
    - i. Proxy Form;
    - ii. Special Confirmation with Blocking Notice;

2. **Vote Submission through the Clearing System:** Vote Submissions may be cast **during the Voting Period** by submitting an electronic voting instruction (including a Special Confirmation with Blocking Certificate) to vote and to block the relevant Notes in the relevant Clearing System until the end of the Voting Period, given in such form as is specified by the Clearing System from time to time. Noteholders who wish to submit their vote through the Clearing System, **should contact their depository bank** as soon as possible to check the specific process set out with their bank.
