

Privacy Policy

Welcome Peoples Depot (PD)! Statement of Privacy.

PD is committed to protecting your privacy. This Statement of Privacy applies to PD Web site www.getprotectivemasks.com and governs data collection and usage at all PD sites and services; it does not apply to other online or offline sites, products or services. Please read the PD Statement of Privacy. PD is an eCommerce web site. Personal information of all users is collected, used and disclosed as described in this Statement of Privacy.

Collection of your Personal Information

They are required to maintain the confidentiality of your information and are prohibited from using that information for any other purpose.

PD does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

PD may access and/or disclose your personal information if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on PD or the site; (b) protect and defend the rights or property of PD including its Web site; or (c) act under exigent circumstances to protect the personal safety of users of PD or the public.

Personal information collected on this site may be stored and processed in the United States or any other country in which PD or its affiliates, subsidiaries or agents maintain facilities, and by using this site, you consent to any such transfer of information outside of your country.
