### **CORRECTION TO AN APPENDIX 2A PREVIOUSLY ISSUED**

AssetOwl Limited (ASX code: AO1) (**Company**) advises that the Appendix 2A provided to ASX on 1 June 2021, titled "Appendix 2A – Placement, non-related parties" contained an error.

In section 5.2 of that Appendix 2A, the Company disclosed that the number 'AO1AK' Options - exercisable at \$0.012 on or before 30 June 2025 – on issue is 1,000,000.

The Appendix 2A appended below is identical to original Appendix 2A with the exception that the number of 'AO1AK' Options is now stated as 2,000,000.

The Company clarifies that this Appendix 2A is not an application for the quotation of any securities, and that "AO1AK" Options were not issued to those investors who received Ordinary Shares pursuant to the Placement which was completed on 1 June 2021.
