WHILE WE CONTINUED TO MAKE STRIDES IN IMPROVING OVERALL CHILD OUTCOMES IN BOTH HAITI AND GUATEMALA, OUR TEAMS QUICKLY ADAPTED TO THE REALITIES OF THE PANDEMIC. EDUCATION, PREVENTION AND RELIEF PROGRAMS WERE DEVELOPED AND PUT INTO PLACE IN EARLY 2020. THROUGHOUT THE YEAR HRI REACHED OVER 500,000 PEOPLE THROUGH THESE EFFORTS.
