In terms of 911 – any deaf individuals call 911? A: we have not gathered info on this yet, but we will do so. Chege: follow up – there are interpretation services for deaf. Unsure if 911 can identify that call is coming from a deaf individual. Chief Drumm – usually texts. Possibly three people registered in Madison. Would be difficult from outside the town. Challenge to a larger community as well.
