STAFF AND BOARD MEMBERS AT THE
90TH ANNUAL MEMBERSHIP MEETING
Friday, February 21, 2020



PosTel celebrated its 90th Annual Membership Meeting on Friday, February 21, 2020 at the Great Hall of Our Lady Queen of Peace Catholic Church in Wichita Falls. The meal was provided by The Branding Iron and the pre-meeting music was performed by the Wichita Falls Youth Symphony Orchestra.

The meeting was called to order at 7:00 P.M. by Joe Ryckoff, Chairman. Mike Rucker, of the Bible Baptist Church, gave the invocation and after the singing of the National Anthem by One Voice, the business meeting began.

Joe Ryckoff delivered the Chairman's Report which included a moment of silence in memory of the departed members during the past year. He also presented the financial condition of the credit union.

Rick Hanson delivered the President's Report recognizing the veterans in attendance thanking them for their service and sacrifice for our country. He then introduced each of the credit union staff, thanking them for their devoted loyalty to PosTel. He delivered a brief history of PosTel Credit Union from its beginning in 1929. He also stated 2019 was the finest year PosTel has ever experienced and the strength of PosTel relates back to the members and the close, family relationship they share with the employees and each other. Mr. Hanson thanked the

directors and staff of PosTel and he also expressed how much we are looking forward to serving the community and members of PosTel for generations to come.

Weldon Day, Director and Chairman of the Scholarship Committee, announced the seven 2019 scholarship recipients and encouraged all members who are graduating high school seniors to apply for the education scholarships PosTel has each year to award.

Joe Ryckoff then reported that the CPA firm of Clifton-Larson-Allen, LLP performed an Audit of the credit union and no material exceptions or findings were noted. He also reported the last State Examination was performed in March, 2019, with no significant exceptions or findings.

Bill Yates, Director and Chairman of the Nomination Committee, announced that, in accordance with the PosTel Family Credit Union Bylaws, John Luig, Jr. was nominated for a two year term and Robert Fonck, Greg Ungs and Joe Ryckoff were the nominees for three year terms of the three additional director positions up for election. A motion was made and seconded that these four be elected by process of acclimation. The motion carried.
