HOW WE COLLECT YOUR INFORMATION:

We collect all information we need to perform under contract with you, directly from you.

You are responsible for making sure you give us accurate and to date information.

HOW WE USE YOUR INFORMATION:

We only use your information where we allowed by law e.g. carrying out agreement we have with you, fulfilling a legal obligation, because we have a legitimate business interest or where you agree to it.

WHO WE SHARE YOUR INFORMATION WITH:

We may share your information with Her Majesty's Revenue and Customs (HMRC) as well as Companies House. We may also share your information with credit reference and fraud prevention agencies.

HOW LONG WE WILL KEEP YOUR INFORMATION:

We will keep your information for as long as you have a relationship with us. After the relationship ends, we will keep it where we may need it for our legitimate purposes e.g. legal obligation under HMRC or responding to request from regulators.

SECURITY

We are committed to ensure that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect physically and online.

YOUR RIGHTS:

You have a number of rights relating to your information e.g. to see what we hold, to ask us to share it with another party, ask us to update incorrect or incomplete details, to make a complaint, etc.

YOUR RIGHTD

Access and correction of your personal information You have the right to access the personal information that we hold about you in many circumstances. This is sometimes called a 'Subject Access Request'. If we agree that we are obliged to provide personal information to you (or someone else on your behalf), we will provide it to you or them free of charge. Before providing personal information to you or another person on your behalf, we may ask for proof of identity and sufficient information about your interactions with us that we can locate your personal information.

If any of the personal information we hold about you is inaccurate or out of date, you may ask us to correct it. If you would like to exercise these rights, please contact us as set out below. Right to stop or limit our processing of your data You have the right to object to us processing your personal information if we are not entitled to use it any more, to have your information deleted if we are keeping it too long or have its processing restricted in certain circumstances. If you would like to exercise this right, please contact us as set out below.

HOW LONG WILL WE KEEP YOUR INFORMATION FOR?

We will retain a record of your personal information. This is done in order to provide you with a high quality and consistent service. We will always retain your personal information in accordance with law and regulation and never retain your information for longer than is necessary.

SECURITY

We take security measures to protect your information including:
