How?	All financial companies need to share customers' personal information to run their everyday business. We also maintain other physical, electronic and procedural safeguards to protect this information and we limit access to information to those employees for whom access is appropriate.

Definitions

Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. <i>First State Bank of Bedias has no affiliates.</i>
Nonaffiliates	Companies not related by common ownership or control. They can be financial or non-financial companies. <i>First State Bank of Bedias does not share with nonaffiliates so they can market to you.</i>
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products and services to you. <i>First State Bank of Bedias doesn't jointly market.</i>
