Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. <i>First State Bank of Bedias has no affiliates</i> .
Nonaffiliates	Companies not related by common ownership or control. They can be financial or non-financial companies. First State Bank of Bedias does not share with nonaffiliates so they can market to you.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products and services to you. <i>First State Bank of Bedias doesn't jointly market</i> .
