OUR MISSION

HSA RECEIVES GRANT

The Watertown Area Community Foundation has awarded a \$300,000 multi-year grant to support the Appropriate Regional Facility being constructed as part of the local Human Service Agency campus.

The multifaceted complex should be completed late 2022 and will more fully address mental and behavioral health with a key benefit of the facility being a number of "safe" beds.

"I feel fortunate the Human Service Agency has the opportunity to make an impact in so many ways with our new facility," said Kari Johnston, HSA executive director. "We will continue to offer recovery of men living with a mental illness and addiction in our halfway house but also support anyone experiencing a mental health crisis in our new ARF beds. In this capacity we can hold anyone in crisis for up to five days instead of disrupting their lives even further by sending them to a psychiatric hospital in Sioux Falls or Yankton."

"The Foundation sees this as an opportunity to make our community stronger," said Jan DeBerg, WACF executive director.

"Not only is the new facility important for individuals who will use it, it is extremely impactful for the community as a whole," agreed Joel Vockrodt, WACF Board chair. "We understand the pressure it will also relieve for local law enforcement, the hospital... it will help the whole system. It's a needed piece."

Johnston stressed that having up to five days to help clients reach goals and a plan is a huge benefit compared to the current system. "The new ARF enables them to stay in their community and near their support system," Johnston said. "In this manner, we serve more than the person experiencing the crisis; we are also providing hope and support for the entire family within their home community."

With that in mind, the Friends of South Dakota Public Broadcasting Fund has been established at the Watertown Area Community Foundation.

WACF is among five foundations across the state that will administer these funds.

The public is encouraged to support SDPB through gifts to the fund. If they wish, donors can direct their gifts to the fund to support whatever programming fits their passion. Gifts can be designated to news, the arts, education, sports or all of the above.







COUNTY FAIR GIVES BACK – County Fair Foods established the County Fair Foods of Watertown Fund in 2021 to assist local nonprofits and charitable groups. GLACIAL LAKES RUBBER & PLASTIC GIVES BACK - Coming off the tails of a challenging pandemic year, a successful 2021 is meaning more than ever to local business professionals Robb & Jodi Peterson. In turn, the couple thinks sharing that success with employees and the community makes perfect sense.

Glacial Lakes Rubber & Plastics opened in 2014 with one employee. The company has grown to 65 employees and has received accolades along the way, including representing South Dakota in the Made In America recognition event at the White House in 2018.



The company expanded in more ways than one and a new building was built. The factory was able to move into the new building in 2020 but postponed the Grand Opening due to COVID. 2021 brought more reason to celebrate as they finally conducted the grand opening.

"It was an unexpectedly good year and we wanted to give back," said Peterson. Giving back has meant bonuses to the employees and matching that with \$15,000 to the Beacon Center and \$15,000 to the Watertown Area Community Foundation to establish a fund which will continue to give back. The Glacial Lakes Rubber & Plastics Fund will be "unrestricted" meaning that the Foundation will make the decisions on what causes and organizations the fund will support and that may change from year to year.

"We wanted to touch as many people as we could and the Foundation does that," Peterson said, crediting his wife with the idea. "The Foundation is in touch with community needs and the resources at the Foundation are well managed."

YOUTH COUNCIL AWARDS NEARLY \$20,000 IN GRANTS

The Watertown Area Community Foundation Youth Council has awarded \$19,230 in grants to area youth-serving programs and organizations.

This year the Youth Council had additional monies to award due to a \$5,000 gift from the Watertown Development Company. The Foundation Board also decided to increase the Youth Council's granting dollars from the traditional \$7,500 to \$10,000 going forward. In addition, if Youth Council grant requests could be matched with restricted fund dollars, \$5,000 more could be awarded bringing the total available for granting to \$20,000.

The following received grants:

- \$730 to Beacon Center to purchase a variety of play therapy toys.
- \$1,000 to the Boys & Girls Club to purchase supplies and equipment for outdoor activities.
- \$500 to East-Central CASA to purchase a laptop and software to improve capacity and services.
- \$2,000 to Friends of SD Public Broadcasting for ELI program materials and curriculum outreach to childcare providers.
- \$400 to Glacial Lakes Multicultural Center to support cultural activities.
- \$1,200 to Habitat for Humanity of Greater Watertown Region for a utility trailer to be used at the building site and a Cricut for creating items for the office, volunteers and clients.
- \$2,000 to Lake Area Child Protection Team, Inc. for foster parent events and recruitment materials to increase the number of foster families.
- \$3,000 to Lake Area Tech EduCare Center for a stroller, plasma car, sensory table, education rugs and infant gates.
- \$1,500 to the Lake Area Zoological Society to purchase/build a naturalistic climbing system including safety pad.
- \$1,800 to PACH to purchase flatbed carts for the PACH warehouse.
- \$1,200 to Watertown Area United Way for more inclusive marketing of Spanish, braille, large print and audio formats for the local Imagination Library.
- \$1,500 to Watertown DASH to purchase books for officer and second-grade students to take home and read with parents.
- \$1,600 to the Watertown Lacrosse Club to purchase 10 new lacrosse helmets for the program.
- \$800 to Watertown Parks & Recreation Department to purchase Playstation 5 game and 4 wireless controllers to start an Esport program for area youth.

First-ever Playstation 5 tournament through the Watertown Park & Rec Department occurred over Christmas break 2021 thanks to a Youth Council grant awarded to establish a local Esports program.





Thanks to generous donors, thousands of dollars in grants and scholarships have recently been awarded by the Watertown Area Community Foundation Women & Giving Advisory Committee.

"These grants and scholarships greatly impact women and children in our area," said Jan DeBerg, WACF executive director. "It's all part of Women & Giving's ongoing mission to help area women and children overcome barriers, increase their opportunities and achieve their goals."

Our fund-raising campaign resulted in more than \$60,000 in gifts, some of which were designated for the Women & Giving Endowment Fund and others for immediate grant-making.

The 2021 grants awarded are:

- \$8,085 to Beacon Center for set up of Life Skills Training Room.
- \$2,500 to Boys & Girls Club of Watertown to purchase Big Blue Block set.
- \$11,140 to Brothers & Sisters Behind Bars for rent and utilities for women's transitional housing unit.

- \$2,500 to Drug Court for incentives for participants.
- \$2,000 to Community Transit of Watertown/Sisseton, Inc. to provide transportation for clients of Beacon Center and Codington County Community Health Services.
- \$1,250 to Inter-Lakes Community Action Partnership to support the Delta Dental Mobile visit. More than \$30,000 in dental services was given to 34 children.
- \$8,630 to Lake Area Zoological Society's Girls Rule
- \$600 to LATC Educare for supplies for low-income families.
- \$672 to Lincoln PTO to provide toiletry bags/supplies to fourth-grade girls in Watertown.
- \$500 to Watertown Area Snow Queen to help pay for self-defense, suicide awareness and art classes for participants.
- \$1,475 to Watertown Area United Way to support the Dolly Parton Imagination Library.
- \$3,000 to Watertown Regional Library to assist with items for a nursing/sensory room.
- \$2,000 to Watertown School District for household/hygiene items for needy students/ families.

The Women & Giving Committee also awarded the following non-traditional, female students



each a \$1,000 scholarship: Krystal Kadoun, attending Lake Area Technical College; Marcy Kohl, attending Mount Marty College in Watertown; Melissa Lorenzen, LATC; Misty Maakestad, LATC; Haley Skinner, LATC; Lacey Small, LATC; and Cassie Swedeen, Mt. Marty.

Women & Giving supported a new sensory/nursing room at the Watertown Regional Library. It included sensory manipulatives for the room and kits to check-out, a new nursing chair, items for sensory story time and continuing education.





Watertown Middle School's Girls Night Out supported by a Women & Giving grant. Dr. Melanie Weiss shared her impactful story of opioid addiction, recovery and success with about 140 girls during the event. The evening also included food, fellowship, break-out sessions and door prizes.



Another grant helped support rent and utilities of a housing unit for four women who are clients of Brothers & Sisters Behind Bars. The grant helps BSBB provide safe and sober housing for up to four women throughout the year. In addition, it enabled them to have some positive social events with their children.

"I am very grateful for everything that I have experienced here. I think back and should have made the move long ago. But fear can keep people unhappy and still. But I'm ready to leave that all in the past and plant seeds in a good way now."

Through our Area School Partnership Program the Foundation awards grants for public education projects which are beyond the scope of the regular school budget. School districts within approximately 30 miles of Watertown are eligible to apply for grants up to \$2,500 on an annual basis.

The 2021 Area School Partnership Grantees are:

- Clark School District to purchase cameras (vision sensors) to attach to the robotics created by students.
- Estelline School District to purchase 25 licenses of the Microsoft Office TestOut Certification software.
- Florence School District to support bringing Missoula Children's Theater to Florence Elementary School.
- Hamlin School District to purchase pitched quad tom drums with carrier, pug mill for recycling and a 3D printer.

At the end of the year, Giving Back 365 donors voted on the grant applications received. The organizations receiving Giving Back 365 grants for 2021 are:



- Watertown Area United Way, \$2,000 to cover half of billboard advertising for the 2022-2023 United Way campaign.
- Watertown Artwalk, \$1,900 to assist with insurance coverage of the sculptures including transit coverage.
- Watertown Figure Skate Club, \$1,635 to purchase costumes for WFSC to be used for its ice show and costume closet.

"A simple \$1 a day accomplishes so much," said Jan DeBerg, WACF executive director. "These dollars mean a lot to the organizations that receive the grants and the individuals they serve."

Since the Public Opinion newspaper business is no longer owned locally and the building is for sale, plans were made under the direction of Christy Lickei, CCHS director, to obtain the archives and secure and store them in a safe and private location. BOYS & GIRLS CLUB – A grant was awarded to the Boys & Girls Club of Watertown to support a new behavioral health program for the club. \$10,000 will be awarded each year for three years (\$30,000 total) to support salary and benefits for a mental health specialist, training and development, start-up equipment and technology and youth program materials and incentives. Statistically, one in five children are experiencing underlying mental health concerns and many are not able to receive timely care with behavioral or mental health needs. Waiting lists within private counseling services are averaging from 3 to 6 months. The Boys & Girls Club hopes to bridge some of that gap. This program also plans to monitor behaviors while building positive relationships and including play therapy or small group prevention-based classes or activities.

HOMELESS TO HOMEBOUND

EDITOR'S NOTE: The following story, written late fall 2021, deals with steps being taken to support the homeless in our community. The statements in bold came from an individual who has been helped. She was unable to share much of her background due to the trauma she and her family have endured. Her name remains anonymous to protect her privacy.

"Home" may mean different things to different people, but just having a place to call "home" can be difficult for some. Thankfully, the Watertown Area Community Foundation has partnered with organizations to bring "home" to many over the past year.

WACF grants have been awarded to support emergency housing, as well as transitional housing for women, through the efforts of Brothers and Sisters Behind Bars, Codington County Welfare and Inter-lakes Community Action Program working with the Department of Social Services, Midwest Bible Camp and other agencies.

"My two daughters and I were able to stay in the apartment for about five weeks this summer. It was relieving. Before we didn't know where we were going to be."

"We took possession of the apartment June 1. The first person placed there was on June 23. Since that date, someone has been in there pretty solid," said Sara Foust, welfare director of Codington County, "This apartment gives us another option for people who don't have a place to go. It allows us to house individuals and families that otherwise have no place to go beyond the streets. Hotels are an option, but they cost more and are also full much of the time."

The apartment effort has gone well through teamwork. BSBB helped identify the need, Foust explained. The County has a contract with ICAP for case management services for the clients to work toward self-sufficiency, "These three organizations are really how the partnership works," in addition to other agency support and financial support from organizations like the Foundation.

The "self-sufficiency" Foust describes may mean steps toward permanent housing, job sustainability, even accountability/support with drug and alcohol sobriety.

"For the most part, it is going well. My case worker is helping me figure it out. We don't have a vehicle, but they gave us some Transit tokens that have helped us get around." (Tokens to Community Transit also supported by a Women & Giving grant.)

"Clients are initially allowed to stay up to two weeks as long as they are actively pursuing permanent housing and working with their case manager," explained Stacy Hendricks of BSBB. "If they are able to line up housing, but need more time until that housing is available, they will be allowed to stay until the planned housing becomes available."


In the transitional housing for women, supported by a WACF Women & Giving grant, women tenants must meet certain criteria and goals in order to stay. Hendricks reported, "After a little over three months, the support from WACF has allowed us to welcome our seventh guest! The house is currently full with four women living there. Like with any new adventure, there has been a learning curve, but we remain fully committed to the work God has called us to in providing a safe and sober home for women to be able to live in for years to come."

"Case management is a crucial piece," said Foust. "This isn't just about housing. They are busy doing things they need to do to get to a stability point. And each case is a little different. One just needed a very temporary place. She already had a job, so she just checked in a couple times a week. Another one may have 'homework,' deadlines, etc. and need much more support - it's very individually based."

"I don't know what 2022 looks like," said Foust. "This was the first year for this program. Seeing the needs and our housing shortage I don't know what will come but I'm very optimistic about the commitment of our community to figure out solutions."

There is a new scholarship fund at the Watertown Area Community Foundation that celebrates that. Wayne Arnold Keup was a member of the Watertown High School speech and debate national championship team of 1965 and 1965 WHS graduate. After passing away at age 73 in 2021, his family established the **Wayne Arnold Keup & Donus Roberts Speech and Debate Scholarship Fund** at WACF.
