New Tax Deadline

When is your tax deadline for the taxes on year 2020? Your accountant should be telling you this, however, it never hurts to know about deadlines and some other things about your taxes, for example, are you and your business taxed as an individual or as a corporation? Most Single-Owner LLC companies are taxed as an individual. Over the last two years, as part of the COVID-19 response from the IRS the deadline has been extended

Payroll Protection Program (PPP Loans)

The Small Business Administration (SBA) instituted the PPP loans as part of their Covid-19 response effort. The loans are locally allocated and funded by financial institutions across the USA, there have been two loan programs setup under this response effort.




How did your story start?
