

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to outoftheblueproductions.llc and Out of the Blue Productions, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Out of the Blue Productions, LLC include outoftheblueproductions.llc and Out of the Blue Productions. The Out of the Blue Productions website is a Literary and film production site. By using the Out of the Blue Productions website, you consent to the data practices described in this statement.

Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Sharing Information with Third Parties

Out of the Blue Productions does not sell, rent or lease its customer lists to third parties.

Out of the Blue Productions may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Out of the Blue Productions, and they are required to maintain the confidentiality of your information.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Out of the Blue Productions. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Out of the Blue Productions website.

Use of Cookies
