What is this product?

Type

The Fund is a public limited liability company with variable share capital (SICAV-SIF), established as a specialized investment fund (SIF). The Fund is one single legal entity and has an umbrella structure consisting of one or several sub-funds. The Fund is authorized as an undertaking for collective investment (UCI).

Objectives

The Sub-Fund invests in European credit related instruments, such as bonds and loans with a higher return than other fixed income instruments, or structured credit instruments. We aim at exploiting market inefficiencies, focusing on European markets.

The Sub-Fund aims at achieving a net return of 8-12% per year over the medium term investment horizon.

Given their characteristics, the instruments in the portfolio may have relatively large movements in their prices that may have an impact on the return of your investment.

Intended retail investor

The Fund is intended for well-informed investors who are able to make an informed investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below.

Term

The Sub-Fund has been established for an unlimited period of time and is open-ended. However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest. Please refer to the Offering Document of the Fund for further details on closure of sub-funds.

What are the risks and what could I get in return?

Risk Indicator



The actual risk can vary significantly if you cash in at an early stage.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest EUR 10,000. The figures are estimates and may change in the future.
