Checks or Cash

You may place your gifts in the offering plates on Sunday morning, or mail checks to Rise Church.

ACH Authorization

You can have your payment deducted automatically from your checking or savings account. It is convenient, saving time and postage. To provide ACH Authorization, stop by or contact the church office.

Your Bank's Online Bill Pay Tool

Simply set Rise Church up as a vendor and direct your bank to send your donation to us at the same time pay your bills. If you set this up as a recurring (or automatic) transaction, you'll never have to touch it.

PayPal

Sign into your [PayPal account](#), click on Send & Request, enter "calvinonthehill@gmail.com", click "Next", change "Paying for a Good or Service" to "Sending to a Friend", follow the instructions from there. Using this PayPal method will waive all transaction fees and result in Rise receiving 100% of your contribution.

Via Our Website

Click on “Give” in the menu of [our website](#). This will take you to the PayPal site and all you have to do is follow the instructions. You'll need a PayPal account, which you can start on the [PayPal site](#). This PayPal method has transaction fees (~3%), which Rise Church will pay. You will get credit for 100% of your donation on your giving statement. For more information, contact the office.

Qualified Charitable Distributions

If you are over age 70 1/2, you may wish to consider direct transfers from your IRA to Rise Church. These gift transfers are not deductible for tax purposes, but help meet your Required Distributions (up to \$100,000) and are not counted as taxable income. Consult with your tax or financial advisor if you are considering a QCD. Contact our office and ask for our treasurer for more info.

Gifts of Appreciated Securities

Rise Church accepts for immediate sale gifts of appreciated securities transferred to the church brokerage account. These gifts can provide a charitable deduction for the market value of the security while avoiding taxes that may be due on the appreciation. Check with your tax advisor about how this would apply to you. Contact our office and ask for our treasurer for more info.
