In 2015, we successfully launched an inhouse Immigration Clinic – which operates under the auspices of our Black & Latino Association – to increase awareness and engagement on pro bono immigration matters across the firm.

#### Not-for-Profit Incubator

Over the past decade, our attorneys and staff have incorporated and obtained tax-exempt status for nearly 400 not-for-profit organizations under the umbrella of the Not-for-Profit Incubator.

### **CLN Transgender Name Change Project**

The clients who participate in this clinic are referred by Start Small Think Big, an organization committed to assisting low- to moderate-income individuals build and sustain thriving businesses in underserved communities in New York City.

### **Veterans Life Planning Clinic**

Our Veterans Network Life Planning Clinic strives to empower veterans and low-income seniors to age in place and with dignity, access their legal rights, and live without fear of homelessness. Our attorneys, in partnership with Volunteers of Legal Service (VOLS), prepare wills, powers of attorney, and other essential directives and life planning documents for this vulnerable population.







### Center for Career Advancement

Our Center for Career Advancement provides the framework for Cadwalader attorneys to develop into leaders, learn essential legal, practical and professional skills, and take ownership of their development and career advancement goals.

### **The Career Navigator Program**

Our competency-based approach to talent development is guided by the philosophy that to most effectively aid in the development of our attorneys, they should be provided with a clear set of standards and expectations — known as competencies and benchmarks — to be mastered at various levels throughout their legal career.
