COMMERCIAL INDUSTRIALIZED MODULAR BUILDING

FEE .50 sq. ft. Minimum \$200.00 - Permit Application Checklist:

- ☐ Verify address and Wind Zone Requirement with Kyra Hendrix at (985) 537-7603
- ☐ Flood Zone Determination/**ORIGINAL ELEVATION CERTIFICATE REQUIRED**
 - ☐ 1st Elevation Site/Ground
 - ☐ 2nd Elevation – (FORM SHOT) must be presented to permit office before foundation inspection is performed by any inspector or before requested from the Permit Office Personnel
 - (If pilings are used for this project and in a V Zone, we will need the 2nd EC after banding to show the lowest horizontal beam before build can continue.)
 - ☐ 3rd Elevation / Final Elevation Certificate (This would include but not be limited to all electrical and mechanicals for structure.)
- B-Zone/C-Zone Affidavit (if building outside Special Flood Hazard Area)**
This affidavit can be found under "Supplemental Forms" on our website.
- NOTE:** If Flood Zone Determination is unknown, contact Darla Duet at (985) 537-7603.
- ☐ Approval from Board of Health at (985) 447-0954
- ☐ Complete PERMIT APPLICATION (*found on website*)
- ☐ Site Plan- (*drawing showing the outline of the proposed structure distances from property lines and all other structure include property size & dimensions.*)
- ☐ Land Verification – (*copy of Act of Cash Sale / Donation / Succession / Recorded Lease*)
 - ☐ Parcel Number from Assessor's Office at (985) 447-7242 (*if applicant owns land*)
- ☐ MS4-Stormwater Management Plan (*For more Information contact Office of Solid Waste at 985-537-7603*)
- ☐ Copy of Contractor's License
- ☐ Valid and true copy of Contract for Complete Project
- ☐ Industrialized Modular (*must meet the Wind Zone Requirement for area where it will be installed*)
- ☐ 1 Complete Set of Plans Stamped by Louisiana State Fire Marshal (*one 11" X 17" or on CD*)
- ☐ Fire Marshal Letter for project (*must be less than 180 days old*)
- ☐ Engineered Stamped Foundation Plans (11" X 17" or on CD)
- ☐ Piling Engineering Plans if pilings are needed

NOTE: After piles are driven, you will need the inspection review report from the engineer.

- ☐ Drainage Plan for the Department of Public Works (*For more Information call 985-537-7603*)
- ☐ Contact CZM for information to determine if a Coastal Use Permit is necessary (985-493-6616)
- ☐ ICC Certified Inspection reports from factory before electric is released to this structure. initial
