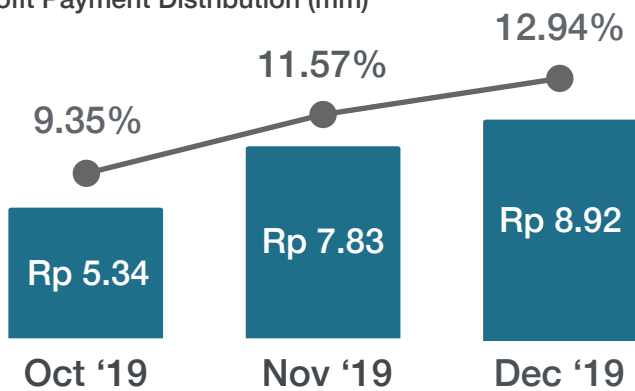
## Overview

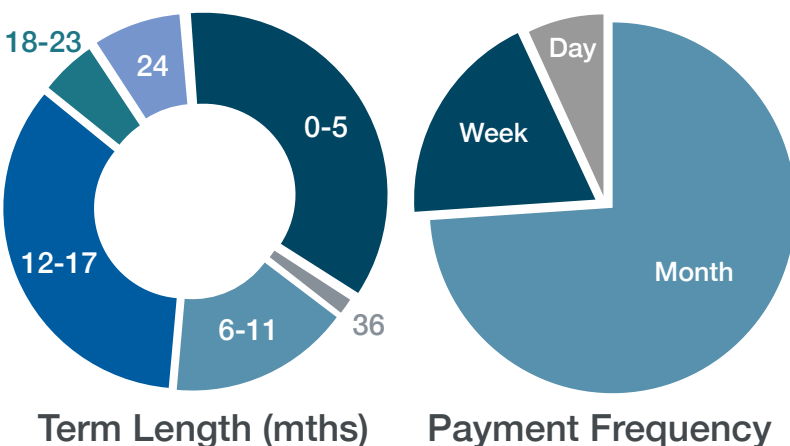
● Gross Annualized ROI

■ Profit Payment Distribution (mm)

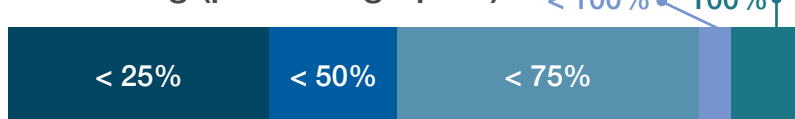
