



## Gold Coast Light Rail

For Easter and the week commencing  
Monday 9 April 2012

### Parklands to Southport

**Motorists and pedestrians are advised to follow the directions of traffic controllers and roadside signage**

Traffic, parking and pedestrian access changes have occurred in the area surrounding Griffith University's Gold Coast campus. A reduced speed limit will be in place as service relocation work continues along Parklands Drive.

Parking along Nerang Street in Southport will be progressively removed between Davenport and Scarborough Streets, and in Scarborough Street between Nerang and Short Streets to facilitate construction commencing in May.

### Main Beach to Paradise Waters

**Alternative trailer parking and boat ramp access**

A temporary site compound will be established at the Proud Park Boat Ramp and Jetty Car Park from 10 April to facilitate the construction of the new light rail bridge and pedestrian bridge over the Nerang River. Public access will not be available from 10 April until further advice.

Alternative trailer parking and boat ramp access will be provided at the Muriel Henschman Park Boat Ramp on The Spit. To access, continue along Waterways Drive, turn left at the roundabout into Seaworld Drive and follow to Muriel Henschman Drive on the left.

Fencing and barriers will be installed adjacent to Commodore Drive on the western-side of the Gold Coast Highway after Easter. A construction site office, lay down area and amenities will be established immediately south of Macintosh Island Bridge North.

A light rail and pedestrian bridge will be constructed on the western-side of the existing Macintosh Island Bridge North as part of these works. Drainage, intersection and road surface works will be undertaken in stages to maintain traffic access in the area.

### Surfers Paradise

**Commencement of works delayed until May**

GoldLinQ continues to work closely with the project's Traffic Management Liaison Group on the organisation of traffic during construction to finalise the optimal solution for Surfers Paradise Boulevard. The anticipated start date of 10 April has been pushed back to allow the appropriate notifications to take place in line with the relevant project approvals and allow traders a construction free school holiday period.

Works are anticipated to commence in the precinct sometime in May. GoldLinQ will notify impacted residents and businesses directly in advance of construction commencing.

### Broadbeach

**Traffic lane opened to allow Easter traffic to flow freely**

Asphalting works have recently been completed in the middle of the Gold Coast Highway near TE Peters Drive.

All existing turning movements will be retained and an additional traffic lane will be made available over the Easter break to accommodate the holiday traffic.

Line marking and bollard relocation will take place next week at night in anticipation for a traffic switch on 12 April. Traffic controllers will be in place, and motorists are advised to observe all signage in the area and be alert to the changed traffic conditions.

A temporary site compound has been established on the corner of the Gold Coast Highway and Pacific Fair Drive to prepare for construction.
