## Appendix [CPO Fees and Payment]

## A. Setup fee

In consideration for the creation of a user account for the Partner on the Platform, the provision of access to the Hubject test system and IT implementation of the connection established by the Partner (collectively referred to as "**Setup Services**") Hubject will charge the Partner a one-off fee in the amount of €5,000.00 plus VAT (where and as applicable) per user account.

Payment of the fee must be made within 14 calendar days following execution of the Agreement; Hubject will provide the Setup Services within three months after payment has been received, provided the Partner, on its part, enables Hubject to do so as required in accordance with the documentation provided to the Partner on execution of the Agreement. If Hubject cannot fully carry out the Setup Services within six months following execution of the Agreement due to a failure on the part of the Partner to enable it to do so and the Setup Services are therefore carried out at a later point, the setup fee will be charged again. The fee payable pursuant to sentence 1 above includes implementation support by Hubject for subsequent OICP releases. If the Partner's connection to the Platform needs to be re-established or an additional connection is to be established, the Partner shall pay a fee of €3,500.00 plus VAT (where and as applicable) for IT implementation of such connection.

## B. Annual fee

In consideration for its use of the Platform and the Platform services the Partner shall pay an annual fee of €1,188.00 plus VAT (where and as applicable). The annual fee becomes due and payable within 14 calendar days following execution of the Agreement and for the following contract years at the start of each billing period.

#### C. Monthly fee

Alternatively, the Partner shall have the right to make monthly payments on the annual fee payable pursuant to section B. above. In that case the monthly fee shall be €114.00 plus VAT (where and as applicable). Payment of the monthly fee shall be made by the 15<sup>th</sup> day of each calendar month.

## D. Ad-hoc charging

In consideration for the services to be rendered under section 6 of the Contract Terms for CPO User Agreements the Partner shall pay a monthly fee in the amount of €5.00 plus VAT (where and as applicable) per charging point for each charging station in respect of which the ad-hoc charging service has been activated. Where a charging station is activated during the course of a calendar month the fee shall be payable for the entire month in question. Payment of the fee must be made by the date on which the ad-hoc charging service is to be activated in respect of the charging station in question pursuant to section 6.3 of the Contract Terms for CPO User Agreements.

# E. Logo

In consideration for each logo supplied to the Partner pursuant to section 5.5 and/or section 6.5 of the Contract Terms for CPO User Agreements the Partner shall pay to Hubject the following fees plus VAT (where and as applicable):

- For each intercharge logo without NFC ordered by the Partner: €1.50
- For each intercharge logo including NFC ordered by the Partner: €4.00
- For each intercharge direct logo without NFC ordered by the Partner: €1.50
- For each intercharge direct logo including NFC ordered by the Partner: €4.00
