the implementation of the program is in response to feedback from teens, parents, shoppers, retailers and community leaders regarding the larger number of unsupervised youth that are coming to the mall on friday and saturday nights. the well-being of our customers is our number one priority. the program is designed to encourage families to take advantage of a pleasant shopping environment and come to the mall together on friday and saturday nights.

1. VISITORS 16 YEARS OF AGE AND YOUNGER ARE REQUIRED TO BE ACCOMPANIED BY A PARENT OR SUPERVISING ADULT AGE 21 OR OLDER ON FRIDAY AND SATURDAY AFTER 6PM. *
2. UNSUPERVISED YOUTH SHOPPING PRIOR TO 6PM ON FRIDAY AND SATURDAY EVENINGS MUST LEAVE THE MALL BY 6PM OR BE JOINED BY A PARENT OR SUPERVISING ADULT AGE 21 OR OLDER.
3. PROOF OF AGE MAY BE REQUIRED FOR THE YOUTH OR SUPERVISING ADULT. THOSE WHO LACK PROPER IDENTIFICATION may be asked to leave the property. valid identification includes a state issued driver's license or id card, A MILITARY ID, A SCHOOL ID CARD, OR A PASSPORT. THE IDENTIFICATION MUST BE TAMPER PROOF AND INCLUDE A PHOTOGRAPH AND DATE OF BIRTH.
4. ONE ADULT MAY ACCOMPANY UP TO 6 YOUTHS.** ALL ACCOMPANIED YOUTH MUST REMAIN WITH THE SUPERVISING ADULT.
5. SUPERVISING ADULTS ARE RESPONSIBLE FOR THE ACTIONS OF THE YOUTH THEY ACCOMPANY.
6. THE POLICY IS IN EFFECT FOR THE ENTIRE MALL EXCEPT FOR STORES AND RESTAURANTS WITH EXTERIOR ENTRANCES.
7. INDIVIDUALS WITHOUT PERSONAL TRANSPORTATION ON FRIDAY OR SATURDAY NIGHT MUST SCHEDULE THEIR DEPARTURE TIME TO ENSURE COMPLIANCE WITH THE FAMILY NIGHT PROGRAM.
8. ANY PERSON VIOLATING THE POSTED FAMILY NIGHT PROGRAM OR CODE OF CONDUCT WILL BE ASKED TO LEAVE THE PROPERTY.
9. YOUTH 16 YEARS OF AGE AND YOUNGER WORKING ON PROPERTY WILL BE ALLOWED ACCESS. PROOF OF WORK STATUS WILL BE REQUIRED, AND YOUTH EMPLOYEES MUST GO DIRECTLY TO THE PLACE OF EMPLOYMENT IF AFTER 6PM ON FRIDAY AND/OR SATURDAY EVENINGS.
10. A PARENT/CHILD REUNION AREA WILL BE PROVIDED FOR THOSE 16 AND UNDER TO AWAIT ARRIVAL OF THEIR PARENTS. A phone is available at no charge so they can call for a ride.
11. UNSUPERVISED SHOPPERS 16 YEARS OF AGE AND UNDER WILL NOT BE ALLOWED TO CONGREGATE IN THE MALL PARKING LOT.
