- The cost of **disposing of rubbish will be significantly higher** than the cost for recycling or for organic waste.
- You could **lower your waste collection bill** as well as do the right thing **by segregating your waste at source into the correct bins** and by adopting simple waste prevention strategies.
- The Government has announced the **establishment of a Waste Management Quality Assurance Scheme** in its new Waste Action Plan to **verify premises are complying with best waste management practices**.
