#### **I. Welcome on behalf of Co-Chairs William Dyson and John DeCarlo**

Co-chair, John DeCarlo, welcomed attendees to the advisory board meeting.

#### **II. Approval of October 4, 2012 minutes**

#### **III. Police Survey Preliminary Summary**

Ken Barone provided a summary on the preliminary information collected from the survey distributed to police agencies. About 70 police agencies reported at the time of the meeting, with more responses expected in the coming week. The survey provided a snapshot of who is collecting traffic stop information and how they are collecting that information. It has provided an opportunity for the project staff to connect with different police agencies to discuss the project. ##### **a. Data Elements Report**

Jim Fazzalano provided an update on the status of the data elements currently being deliberated by the Data, Methodology and Analysis working group. Jim Fazzalero briefed the advisory board on what will be included in the progress report to the Legislature in January. A draft report will be provided to the advisory board in December for review.

Ken Barone provided a report on the current complaint process for traffic stops in Connecticut, highlighting certain municipalities. He provided examples of Rhode Island and Texas municipalities; as to how they conduct their racial profiling complaint processes.
