AS A SINGLE MEMBER LIMITED LIABILITY COMPANY, VINSON HALL IS TREATED AS A "DISREGARDED ENTITY" UNDER CURRENT INTERNAL REVENUE SERVICE REGULATIONS, AND AS SUCH ALL OF THE INCOME AND EXPENSES FROM THE OPERATING ACTIVITIES OF VINSON HALL PASS THROUGH DIRECTLY TO NMGRF. FEDERAL TAX LAW REQUIRES THAT NMGRF BE OPERATED IN A MANNER CONSISTENT WITH ITS INITIAL EXEMPTION APPLICATION IN ORDER TO MAINTAIN ITS EXEMPT STATUS. MANAGEMENT HAS ANALYZED THE OPERATIONS OF NMGRF AND CONCLUDED THAT IT REMAINS IN COMPLIANCE WITH THE REQUIREMENTS FOR EXEMPTION.

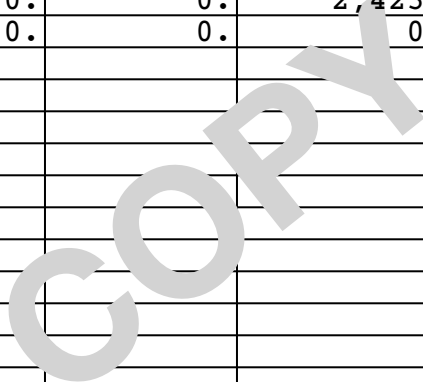

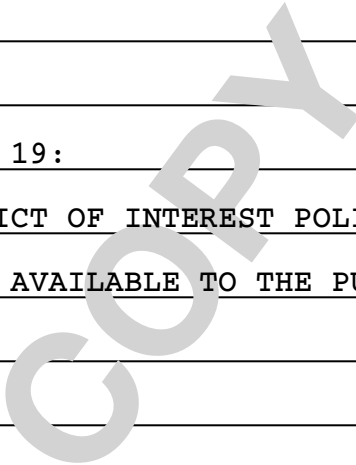
