This application form is for an Enriched Learning Grant. This fund is accessible to schools within the Fullabrook CIC area of benefit only. We are aware that local schools are the heart of our communities, and that our young people represent a large number of our local residents. We think it is important to invest in their future. Each school has a nominal budget per academic year, based on the number of pupils in school. Contact our administrator by email admin@fullabrook-cic.org for information on the budget for your school.

This funding can be used for enrichment projects that are not part of the statutory curriculum or statutory funding obligation, such as trips, workshops, music etc. Movable assets such as sports equipment and computers are acceptable.

This fund cannot be used for capital enhancements or improvements to school land or buildings, or for the purchase and installation of fixed assets. We cannot fund services or purchases that should otherwise be considered a statutory responsibility of the Local Education Authority. We cannot fund benefits to individuals, such as bursaries for trips and residentials, though the funding can be used to subsidise a whole-class activity. We will not fund applications that do not clearly show that they directly benefit the children.
