Centering Lived Experience - Think of Us believes that any + every project in child welfare should be based in lived experience - our team works directly with government, tech, media and philanthropy to deeply integrate folks with lived experience into significant projects in the field. Our approach is unique - in the words of a client: "I've never seen data presented this way, it moves your mind, it moves your heart, this report is perfect." The Hack Foster Care Lab- there are a myriad of things we can do to create immediate solutions.
