The following table explains the types of data we collect and the lawful basis, under current data protection legislation, on which this data is processed.

We use cookies to enable our website to function effectively, to improve your experience and to determine and improve the effectiveness of our website.

4. HOW WE USE YOUR DATA

We will only use your data in a manner that is appropriate considering the basis on which that data was collected, as set out in the table at the top of this policy.

For example, we may use your personal information to:

- reply to enquiries you send to us;
- monitor the effectiveness of our Cook for Good projects, activities, services and policies;
- where you have specifically agreed to this, send you marketing communications by email relating to our work which we think may be of interest to you.

5. WHEN WE SHARE YOUR DATA

We will only pass your data to third parties in the following circumstances:

- you have given consent to us to pass data to a named third party;
- we are using a third party purely for the purposes of processing data on our behalf and we
 have in place a data processing agreement with that third party that fulfils our legal
 obligations in relation to the use of third party data processors; or
- we are required by law to share your data.

In addition, we will only pass data to third parties outside of the EU where appropriate safeguards are in place as defined by Article 46 of the General Data Protection Regulation.

6. HOW LONG WE KEEP YOUR DATA

We take the principles of data minimisation and removal seriously and have internal policies in place to ensure that we only ever ask for the minimum amount of data for the associated purpose and delete that data promptly once it is no longer required.

7. RIGHTS YOU HAVE OVER YOUR DATA

You have a range of rights over your data, which include the following:

- Where data processing is based on consent, you may revoke this consent at any time and we
 will make it as easy as possible for you to do this (for example by putting 'unsubscribe' links
 at the bottom of all our marketing emails).
- You have the right to ask for rectification and/or deletion of your information.
- You have the right of access to your information.
- You have the right to lodge a complaint with the Information Commissioner if you feel your rights have been infringed.

Please note that relying on some of these rights, such as the right to deleting your data, will make it impossible for us to continue to deliver some services to you. However, where possible we will always try to allow the maximum access to your rights while continuing to deliver as many services to you as possible.

8. COOKIES & USAGE TRACKING

A cookie is a small file of letters and numbers that is downloaded on to your computer when you visit a website. Cookies are used by many websites and can do a number of things, eg remembering your preferences, recording what you have put in your shopping basket, and counting the number of people looking at a website.

Overview of the types of cookies we use:

Where cookies are used to collect personal data, we list these purposes in section 2 above, along with other personal data that we collect.

Analytics – We use Google Analytics cookies to collect information about how visitors use the website and help us to continually improve our content. For instance, which pages visitors go to most often and if they get error messages from web pages. These cookies don't collect information that identifies you. All information these cookies collect is aggregated and therefore anonymous. We use this data to help us to understand:

- which pages people visit on the site,
- · which internet browsers are being used,

- what is popular on our website,
- the user journey through the website.

Cookies to Improve your Experience – we use a small number of cookies on our website to help you get the best experience. We also embed YouTube and Vimeo films on our website. We are unable to prevent these sites, or external domains, from collecting information on your usage of this embedded content. If you are not logged in to these external services then they will not know who you are but are likely to gather anonymous usage information for example, number of views, plays, loads etc.

How to manage your Cookie settings

It is possible to stop your browser and/or mobile device accepting cookies either generally or from specific websites. However, you may find that some aspects of our website stop working or work less well if you do this. For this reason, we do not recommend turning cookies off when using our website.
