

Extension Cord Safety

- Use on temporary basis.
- Keep unplugged when not in use.
- Keep slack, don't stretch tight.
- Don't place across doorways, heavy traffic areas, or under rugs.
- Do not staple or nail to wall.
- Do not alter a 3 prong plug.
- Do not use "indoor" cords outdoors.
- Store all cords indoors when not in use.
- Never use in wet condtions.

Wild Rice Electric Cooperative has an aggressive plan this year to replace six miles of underground wire and more than 10 miles of overhead wire with three-phase underground. These changes will increase the reliability in our service territory. We also will be building new services, performing system improvements, changing poles, as well as vegetation management. This month crews plan to work in Erie and Oakland

Your cooperative was awarded a safety grant from the state of Minnesota. The Minnesota Department of Labor and Industry created a program in 1993 to assist employers looking to make their work places more safe and healthy.

With this grant, Wild Rice Electric Cooperative purchased five battery operated ergonomically-friendly power tools for construction and maintenance on power lines, and a regulator neutral detector that positively confirms the system is ready to be bypassed. The regulator neutral detector will sense equipment failure that could cause serious injury to our line workers.

These items will have a positive daily impact on our line workers by enhancing their safety, productivity, and ultimately aid in achieving our safety goal of zero injuries.

DON'T GET BURNED ON SOLAR SCAMS

Wild Rice Electric Cooperative supports making electricity more environmentally responsible while keeping power reliable and affordable for our members. However, we've been alerted that some deceptive companies are beginning to take advantage of our members' growing commitment to going "green." Many are offering too-good-to-be-true solar panel systems that may leave you in debt – and in the dark. Not all solar companies are out to scam you, but be on the lookout for these signs.

Dishonest leases can be disguised as great financing options for new solar panels for your home. A scammer may lure you into thinking you own the panels and thus may collect incentives offered by buying panels. However, if you don't outright own the panels, you can't collect incentives or rebates – and the value of the panels is not added to your home.

If you encounter a pushy solar salesperson

who isn't answering your questions clearly, you should take pause. These people may be looking for a sale whether or not solar is right for your particular situation. If they try to force a deal without an onsite inspection or a contract, just say no.

Tax incentives for solar installation are somewhat complicated, and some unreputable companies may try to take advantage of your tax credit confusion. Before speaking with a solar company, make sure you research your eligibility for solar tax credits and other programs, both federal and local.

Some fraudulent companies will try to resemble utility representatives and contact

homeowners by phone, email, or even door-to-door. These salespeople may spout exciting claims that you can get rid of your electric bill entirely or that you will soon miss the boat on important federal tax incentives.

Be wary of any online ads, social media links or emails that tout free or zero-dollars-down solar panels. These are usually scams. Always go through a company's official website to schedule an in-person meeting and solar evaluation.

PROTECT YOURSELF

Contact Wild Rice Electric in the early stages of any solar panel planning – our experts will help you determine if solar interconnection is right for you.

Do your research on available incentives and tax credits (and if you qualify).

Get a few in-person site evaluations and quotes before signing any contract.

Read online reviews of solar companies, including from the Better Business Bureau.

If your gut says something is wrong with a company, trust that feeling.
