

# How electricity gets to YOU

Electricity doesn't just happen – it must be generated, sent incredible distances, and then converted to flow safely to farms and communities. Wild Rice Electric works hand-inhand with wholesale power provider, Minnkota Power Cooperative, to deliver reliable energy at every point in the process.

**Generation** (Minnkota Power Cooperative)

Minnkota produces electricity from a diverse mix of energy sources.

Generation capacity is derived from coal at the Milton R. Young Station in Center, N.D. (near Bismarck). The remainder of Minnkota's generated electricity comes from North Dakota wind turbines, hydropower from Garrison Dam and other resources often referred to as "Market".



### **Transmission** (Minnkota Power Cooperative)


Once the electricity is created at one of Minnkota's generation facilities, it is sent through miles and miles of high-voltage transmission lines across North Dakota and Minnesota.

These lines branch out into multiple local service areas, like Wild Rice Electric Cooperative



### **Distribution** (Wild Rice Electric Cooperative)

This is where your cooperative takes over. The high-voltage power from the transmission line is "stepped down" (or converted to a usable voltage) at a local distribution substation. From the substation, the electricity enters the distribution lines that are built and maintained by your cooperative team. These lines are the last path to your home or business.

#### **AROUND THE CO-**

Line crews continue to work hard on our distribution system with the favorable weather conditions. With these warm temperatures and low snow accumulations, line crews have been able to continue changing out poles and also mow brush efficiently. In past years during late January and into February with below zero temps and heavy snowfall, the crews have been limited to line survey, updating maps, and smaller maintenance and brushing items. This warm weather has been great for productivity but it does come with an elevated risk of a potential ice storm. We were very fortunate over New Years to be missed by the ice storm that caused significant damage to several eastern North Dakota Cooperatives. We were happy to lend a hand to Cass County Electric Cooperative in their restoration efforts with a crew of 5-line workers and various equipment.

Star Energy Services conducted pole testing in October. Every year Wild Rice tests a number of poles to ensure strong reliability on our system. This year we tested 3,340 poles in the Mahnomen, Beaulieu, and Naytahwaush areas. Wild Rice crews will change out as many of these rejected poles as possible during the winter months, once summer construction begins our crews will be busy

# HOW DOES CARBON CAPTURE WORK?

You've likely heard about Project Tundra, a carbon capture and storage initiative being pursued by our wholesale power supplier, Minnkota Power Cooperative, and its partners. If successful, this technology would capture approximately 4 million tons of carbon dioxide (CO2) every year and store it safely and permanently underground - creating a more sustainable power mix for Wild Rice Electric Cooperative.

An air-source heat pump is not like a traditional furnace. Instead of creating heat with electricity, it uses electricity to move warm air from one place to another.
