Dear Parent / Carer,

**Permission to use Recordings (as defined below)**

This letter agreement (the **Agreement**) confirms the terms on which you, .....**(you)** agree to allow Football Beyond Borders (referred to as **FBB** throughout), with a registered address at Unit 4, Warwick House, Overton Road, London, SW9 7JP under UK charity number: 1158046, the right to record for the purposes set out below, including without limitation image and voice recordings, still or video photography, audio tape and all other means of recording technology (collectively, the **Recordings**) featuring your **child, [the child]** of whom you confirm you are the parent or guardian.

1. Pursuant to and in consideration of the sum of £1 (receipt of which you hereby acknowledge), you confirm that:
  - 1.1. you grant FBB exclusive permission to edit or alter the Recordings, such editing or alterations being at FBB's sole discretion, provided always that such editing and/or alterations are not defamatory of the Child or undermine their dignity. You further agree and give irrevocable permission for FBB to distribute, publish, exhibit, transmit, copy, display, live stream and store copies of and/or otherwise use the Recordings along with your Child's name in connection with FBB.
  - 1.2. the Recordings will be distributed and used in connection with and for the purpose of advertising, promoting, publicising and marketing, events and presentations related to FBB's charitable work, services, brand and business (**Specified Purpose**).

- 1.3. the Recordings shall be featured in material, including but not limited to, print media, presentations, promotional materials, websites, social media platforms and applications, software applications, television and mobile technology (**Specified Activities**) in the UK and rest of world, in perpetuity.
  - 1.4. you acknowledge that the Specified Activities may be altered, expanded or otherwise changed by FBB from time to time provided that prior notice of such new activity is given to you.
  - 1.5. you hereby waive any right that you may have to inspect or approve any Recordings that may be used in connection with the Specified Purpose and hereby waive any moral right arising under the Copyright, Designs and Patents Act 1988 or any equivalent, corresponding or alternative rights under other jurisdiction in relation to any intellectual property right, including copyright and any related rights arising in the Recordings.
2. You do not object to FBB:
    - 2.1. storing copies of the Recordings for as long as necessary to fulfil the Specified Purposes or to it storing your contact details on its database in case it needs to contact you; or
    - 2.2. sharing the Recordings and your contact details within the FBB group acting as joint controllers or processors
3. You have the right to withdraw the consent you have given at any time by writing to FBB at [info@footballbeyondborders.org](mailto:info@footballbeyondborders.org) or Unit 4, Warwick House, Overton Road, London, SW9 7JP. This will not affect the lawfulness of any processing carried out by FBB before you withdraw your consent.   4. FBB is the controller and responsible for the personal data comprising the Recordings and your contact details and any related personal data.
  5. FBB will:
    - 5.1. ensure that it complies with the requirements of all legislation and regulatory requirements in force from time to time relating to the use of the Recordings and your contact details and any related personal data; and

5.2. process the Recordings and your contact details and any related personal data in accordance with our Privacy Policy, of which you confirm to have read by signing this Agreement.

6. By signing this Agreement, you hereby agree to hold FBB harmless from and against any and all claims of whatever kind or nature, arising directly or indirectly out of or in connection with this Agreement and waive any right to compensation and agree that you have no claim for injunctive or equitable relief against FBB in connection with this Agreement or Recordings.
7. You acknowledge and agree that no other representations made by FBB relating to the content of this Agreement shall be enforceable.
8. Each party irrevocably agrees that any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with this Agreement or its subject matter or formation) shall be governed by and construed in accordance with the law of England and Wales and if any part of this Agreement is declared unlawful or unenforceable, such part shall be deleted and the rest of the Agreement shall remain in effect.
9. Each party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with this agreement or its subject matter or formation.
