COVERAGE

The rights and protections contained in the California Consumer Privacy Act (the "Act") apply to "Consumers," which the Act defines as natural persons residing in California, including California residents who are outside California for transitory purposes. The Act contains several exemptions from coverage. Please note that the following disclosures apply to Change Home Mortgage's job applicants, employees, contractors, owners, directors, or officers where the personal information we collect about those individuals relates to their current, former, or potential role a Change Home Mortgage.

NOTICE AT COLLECTION

The California Consumer Privacy Act requires that Change Home Mortgage inform Consumers, at or before the time of collection of a Consumer's personal information, of the categories of personal information that may be collected and the purpose for which the categories of personal information will be used.
