State Officer Selection/Student Policies & Procedures

Colorado DECA State Officer Selection Policies

- 1. State officers will be selected at the State DECA Career Development Conference.
- 2. The state officer candidate may not select the position for which she/he is applying. They may however express a preference.
- 3. At the time of selection and throughout the term of office, the state officer candidates must be attending a Colorado high school, be enrolled in a Business Administration Education program, maintain a 2.5 GPA and be an official DECA paid member.
- 4. State officer candidates must submit to Colorado DECA the following by the published State DECA Career Development Conference registration deadline. The following forms will be available at www.coloradodeca.org and must be complete and submitted electronically through the state conference portal.
 - An application for office
 - o A Grade Verification Form
 - Two letters of recommendation (one from a teacher/counselor/administrator (Not DECA Advisor) at your high school, and one from someone who is not associated with the school). One completed online recommendation google form from current DECA Advisor (will be emailed to advisor after state DECA Conference registration deadline).
 - o Electronic Visual Resume
 - One or two page PDF
 - Must include a photo of the candidate
 - Include name of high school and DECA District
 - Optional: In addition to running for a district representative, is there an Executive Position you are highly qualified for?
 - Topic suggestions: Goals, Values, Skills, Extra-Curricular Activities, Accomplishments, etc.
 - Be creative and proofread!
 - Failure to submit all forms, complete and on time as required, will result in the student's application being disqualified.
- 5. State officer candidates must pass, at a level of 70% or higher, the DECA Officer Qualifying Examination. The district advisory board member or chapter advisors are responsible for administering the DECA Officer Qualifying Examination during or prior to the district conference. Results from DLG will be sent to the Colorado DECA State director no later than the district competitive event report. Candidates not passing this test at a level of 70% or higher will not be eligible to run for state office.
- 6. The questions on the Officer Qualifying Examination may be taken from the Advisor Handbook Learning Objectives and the Colorado DECA social media accounts.

- 7. The Officer Qualifying Examination will use DLG and be administered online during or prior to the district conference.
- 8. The following leadership activities will be completed at the State DECA Career Development Conference:
 - a. An individual interview with the candidate
 - A 90 second speech. No props allowed. Use personal examples for support.
 2024 2025 Speech topics are: (The officer candidate will select one of the following)

How will you help Colorado DECA members Jumpstart Their Journey?

What difference will you make on the 2024-2025 DECA state officer team?

- 9. No campaigning or caucusing will be allowed.
- 10. A selection committee will be appointed by the Colorado DECA state director for the purpose of selecting a student to serve as State President, State Vice President, State Secretary, Social Media Director, and State Publicity Director and a student to serve as State Representative to represent each of the DECA districts.

The committee selection members may include, but not be limited to:

- o A non-competing DECA member from each DECA district.
- A former DECA advisor.
- A specialist from another career and technical organization.
- A lead advisor from another career and technical organization.
- Past state/International officers.
- A school counselor.
- A Career and Technical Education (CTE) director.
- A business/industry representative.
- o An alumni.

Each DECA district may select one (1) DECA member to serve on the selection committee at the State DECA Career Development Conference. This student must be a non-competing DECA member.

A state officer may be dismissed from office at the discretion of the State Officer Team Advisor, Assistant State Officer Team Advisor and the DECA State director for any of the following reasons:

- o failure to attend meetings;
- o failure to perform designated responsibilities;
- o conduct not appropriate for a State Officer;
- dropping out of High School/Marketing Education Program;

- o moving from the state of Colorado;
- o GPA below the required 2.5;
- lack of interest.

If the DECA district chooses to have district officers, the following guidelines should apply:

- a. The student must be attending a Colorado high school.
- b. The student must be enrolled in a Business Administration Education program.
- c. The student must be an official DECA paid member.
- d. The student must submit a school transcript to verify a minimum 2.5 accumulative GPA.
- e. A district officer is not eligible to attend the State DECA Career Development Conference unless (s)he is running for state office or competing in an event.
- f. Additional policies/procedures may be enforced by the individual district.

Policies

At the time of selection, and throughout the term of office, the state officer candidate must be attending a Colorado high school, be enrolled in a Business Administration Education Program, maintain a 2.5 GPA, and be an official DECA paid member. State officer candidates must submit to Colorado DECA an application for office, a grade verification form, two letters of recommendation, and a visual resume.

Submit the completed officer candidate application form online to the state director by the published State DECA Career Development Conference registration deadline. In addition, submit the following:

- 1. Grade Verification Form (2.5 GPA minimum)
- 2. Electronic Visual Resume
- 3. Two letters of recommendation, One completed Recommendation Form by DECA Advisor

To become a state officer of Colorado DECA requires commitment on the part of all parties concerned. In order to make that commitment, each party must understand his/her responsibility. In order for a candidate to be eligible for office, this agreement must be signed by all parties indicated.

- REQUIRED activities include:
 - DECA State officer training (March 27-29, 2024)
 - CTSO State Officer Training (June 10-12, 2024)
 - Chapter Leadership Training (September)
 - State Officer Meetings (3 minimum throughout the school year)
 - Two District DECA Conferences 2024
 - State DECA Career Development Conference 2025
 - Other meetings as assigned
- Optional activities include:
 - ICDC (paid by student and travel with home school)
 - Invitationals
 - Events held in your district or nearby

Costs Covered by Colorado DECA

- Officer shirts, ties, scarfs, 1st name tag
- CTSO and Officer training (lodging, food, registration) in April and July
- DECA State Conference (registration, lodging, and food)
- Mileage to and from official DECA business (with complete travel authorization form)
