## APPENDIX A: DEFINITIONS

**Calendar:** chronological list of Events and eSC Series published by eSC Commission or NAMs.

**Championship Promoter:** WES Management Limited.

**Entry:** an Entry is a contract between a Rider /Team and the LOC / eSC Commission concerning the participation of the said Rider / Team to an Event.

eSC: eSkootr World Championship.

eSC Calendar: as defined in Article 1.1.

eSC Commission or Commission for Micromobility and Sport: is the sole international governing body empowered to authorise, govern and control international Micromobility Sports events organised under its jurisdiction throughout the world established as the Commission for Micromobility and Sport.

**eSC Series:** may be composed of one or several Events whose dates are included in a Series calendar to be decided by eSC Commission.

**eSkootr:** the eSkootr SX-1 as defined in the Technical Regulations.

**Event:** single eSkootr competition with its own results, as defined in Article 1. It may comprise heat(s) and a final, free practice, qualifying practice sessions.

**Exhibition:** out of competition activity authorised by eSC Commission or its NAMs as defined in Article 1.4.

**Force Majeure:** any extraordinary and unforeseeable act, event or circumstance beyond the reasonable control of the Commission including acts of god including earthquakes, floods, windstorms or other natural disaster, epidemics, pandemics, acts of government, including the refusal or revocation of any licence or consent, war, armed conflict, terrorist attacks, civil war, explosion, nuclear, chemical or biological contamination, epidemic or pandemic, embargos and closing of borders, theft, malicious damage, strike, lock out or industrial action of any kind, a power failure, failure of telecommunications lines, or a failure or breakdown of plant, machinery or vehicles. For the avoidance of doubt, cases of labour dispute shall not be considered as Force Majeure.

**Licence:** certificate granted by eSC Commission / NAM as defined in Article 2.4.

**NAM:** national affiliated member having sporting authority upon recognition by eSC Commission to sanction micromobility activities on its territory.

**Official:** individuals duly appointed and trained by eSC Commission/ NAM to fulfil operational missions and duties during Events.

**Organiser / LOC (local Organising Committee):** any appointed entity by eSC Commission for the staging of an Event.

**Parc Fermé:** location where a Team is obliged to maintain eSkootrs in accordance with the eSC Sporting Regulations.

**Penalty:** decision of sanction decided by the competent sporting authority as set out in the eSC Commission's Statutes.

**Race:** competition organised on a circuit which allow Riders to compete to each other in the same period of time in accordance with eSC Code.



**Rider:** individual who has been granted an eSC licence to take part in eSC / eSC series

**Start:** moment when the order to start a Race is given to Riders.

**Team:** sporting organisation / entity whose activity is to take part in Events and having been granted a licence by eSC Commission or NAM.
