1. All goods purchased pursuant to this credit agreement shall be used for agricultural or business purposes only.
2. This contract is performable and all accounts are payable at Hope Plantation Turf Farm, in Telephone, Fannin County, Texas, P.O. Box 9, 3765 C.R. 2135, Telephone, Texas 75488.
3. All amounts are due at the time of purchase, and all accounts, which remain unpaid, become past due on the 31st day after purchase.
4. All past due accounts will accrue interest at the rate of 18% per annum, but not to exceed the maximum amount of interest allowed by law in the state in which the products are purchased. Any interest in excess of the maximum amount shall be credited on the principal amount owed on the account or, if that has been paid, shall be refunded.
5. Applicant shall pay for all costs incurred by Hope Plantation Turf Farm for the collection of any past due accounts. Costs shall include but are not limited to reasonable attorney's fees and court costs. In the event that a lawsuit is filed to collect the account, Applicant consents to venue and jurisdiction in the courts in and for Fannin County, Texas.
6. All owners and/or corporate officers, and/or applicants assume responsibility and are liable for payment of all products made by the undersigned or his/her (its) agents for which credit is extended by Hope Plantation Turf Farm.
7. Hope Plantation Turf Farm or its designee is authorized to contact and investigate credit references, to obtain credit reports, and to investigate the information provided by the undersigned or any other person or entity to determine the Applicant's credit worthiness.
8. If any clause or provision of this Credit Sales Agreement is found to be invalid or is incapable of being enforced by any rule of law or public policy, all other clauses and provisions shall, nevertheless, remain in full force and effect.
9. This agreement shall be interpreted according to the laws of the State of Texas.
10. Hope Plantation Turf Farm shall in its sole and absolute discretion have the right to deny credit and may terminate credit privileges at any time in its sole and absolute discretion.
