4. MANDATORY PROVISION OF DATA

6. LOCALISATION AND TRANSFER OF DATA

7. PERSONS AUTHORISED TO PROCESS DATA

8. RIGHTS OF DATA SUBJECTS

8.1 You have the right to request to the Controller access to and rectification or erasure of personal data concerning yourself, the right to have incomplete personal data completed, the right to restriction of processing in the cases provided for by Article 18 of the GDPR ¹; the right to receive the data in a structured, commonly used and machine-readable format, as well as, if technically feasible, to transmit those data to another controller without hindrance if the conditions for exercising the right to portability pursuant to Article 20 of the GDPR are met (the processing is based
