Medication and Health Statement

Introduction

This statement has been developed to provide an overview of the areas of medication and health covered by policies developed and maintained by the education and care service. Goals

Quirindi Preschool Kindergarten will define policies and procedures relating to the areas of medication and health. These policies, informed by the National Regulations and Quality Standards will describe responsibilities, procedures and practices that will guide practice in the education and care service. These practices aim to provide a clean, healthy and safe environment for educators, children and families.

Strategies

The Approved Provider and/or the Nominated Supervisor will:

- Ensure that the Nominated Supervisor, educators and volunteers at Quirindi Preschool Kindergarten implement adequate health and hygiene practices.
- Ensure that educators have the skills, training and expertise required to support the inclusion of children with additional health needs.
- Ensure that educators follow procedures and guidelines set out by the NSW Department of Health and the Education and Care Services National Regulation to keep their environment safe
- Ensure the confidentiality and storage of medication and health records according to regulatory requirements.

The Nominated Supervisor will:

- Implement policies and ensure that educators and volunteers at Quirindi preschool Kindergarten implement adequate health and hygiene practices.
- Maintain information in the enrolment records of all children regarding health and medications in accordance with legislative requirements and with reference to service policies regarding record keeping and confidentiality.

Procedures:

- Regularly review health and medication policies in collaboration with educators and families.
- Develop risk minimisation plans for children who have specific health care needs.
- Liaise with health professionals in the community to ensure that knowledge is updated and shared with families.
