The State of Minnesota has high wiring standards, which are in the best interest of you and your family or business. Improper wiring can damage your home, your property and equipment, and injure or kill the people you love. Currently, the state does allow homeowners to do their own residential wiring; however, it is critical that the current electrical code is followed. Any time you or an electrician does wiring or other electrical work at your home or farm, Minnesota state law requires a state wiring inspector to conduct a proper inspection of the work. A rough-in inspection must be made before any wiring is covered. A final inspection is also required. For more information visit **dli.mn.gov** and go to the electrical page.

Anyone who plans to dig is required by law to notify the state of their intentions at least 48 hours in advance. All digging requires the 48hour notification so that buried telephone line, television cable, pipelines, utility electrical lines, municipal water and sewer lines can be located to ensure that none will be severed or damaged.

### **Preparing for winter**

t's that time of year — time for some clear communication on paying your electric bill. In anticipation of moving quickly through fall to winter, we published the Cold Weather Rule, including contact information for aid agencies, in last month's (September) newsletter. As of Oct. 1 (through April 30), you have some additional protection from disconnection of power if you qualify. If you missed that notice, and need to refresh your recollection of what it covers, you can access an electronic copy of past newsletters from our website.

Communication is the key. It is never our goal to disconnect your power — we're in the business of providing that service but, on behalf of all members, we do require your payment for that service. You should always receive your bill (mailed or electronically) by the 10th of each month. Our payment due date is always the 21st of the month. If that schedule does not work for you to meet your payment requirements, we need to know about it — please call our office so we can document some workable payment arrangements.

We continue to have a very good working relationship with our most-used aid agency, Northwest Community Action, in Badger. If you qualify (or wonder if you qualify) for assistance toward your energy billing, there

is a process to follow. Although we can help you through most of this process, we cannot apply on your behalf. Again, communication and follow-through are the keys, as when we check on possible assistance for you, one of the oft-heard replies is that Northwest is waiting on information to process your application.

A good combination of benefits of membership, including electronic billing (email alerts), budget billing, and automatic payment options are available to help ease you through the winter months where, with electric heating loads, your billing becomes a larger budget burden than in summer.

"Big Truck Night"— recently held at your cooperative — where children (and parents) enjoy hands-on experiences with large agriculture, construction, and emergency use vehicles, is something we enjoy hosting. A car seat check station is set up, assisting area parents with keeping children safe. Again, the biggest hit this year was the Valley Med Flight helicopter. Thank you to Life Care Medical and your associates for using our facility for a very important, wellrun event!

# AVOID HIGH NATURAL GAS AND PROPANE PRICES WITH OFF-PEAK ELECTRIC HEATING

Minnesota and North Dakota households that relied on natural gas or propane to keep them warm through last year's cold season faced volatile prices that sent their heating bills soaring unexpectedly. One year later, natural gas and propane costs remain high – with the potential to climb higher through the winter.

If the possibility of another price spike has you nervous, there's an easy way to prepare now. Simply incorporate electricity into your heating system and enroll in Roseau Electric Cooperative voluntary off-peak program. You'll receive electric heat at nearly half the standard electric rate, which brings your cost for heating well below the cost for natural gas or propane. Plus, the off-peak electric rate has remained stable for nearly a decade, so there are no worries about sudden swings in the market that you didn't work into your budget.

#### How the valuable off-peak program works:

Roseau Electric Cooperative members voluntarily sign up for off-peak, which allows Minnkota (your co-op's wholesale power provider) to temporarily turn off electric heating, water heating, vehicle chargers and commercial account service during times of high regional demand. During these "control periods," most consumers are automatically switched to a backup heating system, generator or stored heat so there is no interruption in comfort.

#### **Electric heat system**

An electric heating system on the off-peak program consists of an electric heat source as its main component and a supplemental heating source (such as fuel oil or propane) that will typically operate 250-300 hours per year during times of peak electrical demand in the region. The program can also be utilized in storage heat technologies, in which heat is collected and stored during low-demand times of day and deployed when needed.

#### **Water heater**

A water heater on the off-peak program will warm the contents of the tank during lower-demand times of day (often overnight), and that water will remain hot until it is needed in the home.

#### Popular electric options eligible for the off-peak program:

#### **AIR-SOURCE HEAT PUMP**



- Can be used with a backup fuel source for off-peak program
- · Eligible for low off-peak rate
- Up to \$700/ton in rebates

#### **ELECTRIC PLENUM**



- Backup energy source is necessary for the off-peak program
- · Eligible for low off-peak rate
- \$50 per kW rebate

#### **THERMAL STORAGE**



- Backup fuel source is not needed for the off-peak program
- Eligible for low off-peak rate
- \$90 per kW rebate

#### **ELECTRIC WATER HEATER**



- Backup fuel source is not needed for the off-peak program
- Eligible for low off-peak rate
- Up to \$900 in rebates

## ARE YOU READY FOR WINTER?

Last winter was brutal.

Countless blizzards and extreme cold weather were made worse by rapid increases in the price of home heating fuels, such as propane, fuel oil and natural gas. With the price of those fuels expected to remain high, it's a good time to consider switching to off-peak electric heating. Off-peak provides your home or business with comfortable, efficient heating, while also protecting you from heating fuel price spikes. The off-peak electric heating rate is remarkably stable in comparison to the alternatives.

So, how does it work? The off-peak program is voluntary for members who allow for their electric heating system to be temporarily controlled and switched to an automated backup resource (like propane or electric storage) during times of peak demand for electricity in the region. In exchange, members receive a discounted electric heat rate, which is about 50% less than standard electricity rate.

Here are a few things we want you to know before the winter season begins.

#### 1. There's still time to switch to off-peak heating

Call our Energy Services Department at 218-463-1543 to discuss your options for adding off-peak electric heating equipment to your home or business. The process is typically simple and straightforward, and your electric cooperative provides great rebates, incentives and other programs to significantly lower installation and equipment costs.

#### 2. There is a potential for earlier-than-normal off-peak load control hours

From now until mid-December, Minnkota Power Cooperative, your electric cooperative's wholesale power provider, will have its largest power plant offline for scheduled maintenance. With this plant not producing electricity, Minnkota may need to utilize off-peak load control to avoid costly electricity purchases from others on the grid. The savings from this practice are passed on to you through the low off-peak rate.

#### 3. Fill your propane or fuel oil tank

Be sure to fill your propane or fuel oil

tank as soon as possible, and make sure your tank is large enough to hold an adequate supply. If your propane tank gets low during extreme cold temperatures, it may not work properly. Remember, prices typically rise as demand increases during the heating season.

#### 4. Check your furnace

Make sure to change your furnace filter regularly. Contact a heating/ ventilation/air conditioning (HVAC) professional to inspect/maintain your system as needed. Early attention to maintenance can help prevent failures in the heart of heating season.

Members have had to spend more on energy to heat their homes and for transportation this past year, but the good news is that the price you pay for electricity is forecasted to remain stable. If you have questions about how to save on your winter heating bills or are having issues making payments, please contact our offices. ## INSTALL SOFTWARE UPDATES



Adding layers of security to access your online accounts has proven to be one of the best ways to protect yourself from malicious cyber activity. Two-factor or multi-factor authentication allows users to confirm who they really are online. Two-factor authentication may come in many forms, including a confirmation text code, an email or even a separate authenticator app.



A new practice for creating strong passwords includes using "passphrases." A passphrase is usually longer than a typical password and includes at least 14 characters with spaces between words. An example of a passphrase would be "secure passw0rds w0rk Great!". Since passphrases are longer and composed of more characters, they are stronger than typical passwords.



Open links and attachments sent to you with caution. If you receive a text message or email that is too good to be true or threatens you if immediate action isn't taken, it is more than likely a scam. If an email comes from a friend or co-worker that seems odd, call the sender and see if they really meant to send the message. Taking the time to verify this information can keep you from being tricked by a link!



Make sure to complete all software updates promptly. Often the updates include protection against the latest security risks. Remember that updates come from apps and not from emails or social media links. If you get an email saying you have a software update, check the app's website to verify if there is one available.
