The State of Minnesota has high wiring standards, which are in the best interest of you and your family or business. Improper wiring can damage your home, your property and equipment, and injure or kill the people you love. Currently, the state does allow homeowners to do their own residential wiring; however, it is critical that the current electrical code is followed. Any time you or an electrician does wiring or other electrical work at your home or fam, Minnesota state law requires a state wiring inspector to conduct a proper inspection of the work. A rough-in inspection must be made before any wiring is covered. A final inspection is also required. For more information visit **dli.mn.gov** and go to the electrical page.

Anyone who plans to dig is required by law to notify the state of their intentions at least 48 hours in advance. All digging requires the 48hour notification so that buried telephone line, television cable, pipelines, utility electrical lines, municipal water and sewer lines can be located to ensure that none will be severed or damaged.

Opportunities to get on board

Our Feb. 6 deadline for petitions is coming up fast! Three seats -Districts 1, 6, and 9 – are up for election to a 3-year term. At this time, only Jim Hallan, District 1, has chosen to NOT run for reelection. His choice creates an opportunity for someone to serve. If you reside in Moranville or Lake (eastern part) township, and are a member in good standing who's ready to serve your cooperative, please stop by and pick up a petition packet! New year outlook

Right before we closed the door on 2023, your board of directors met and approved the 2024 operating budget. While 2022 and 2023 have provided good operating margins, the outlook for 2024, with higher costs of borrowing, slightly higher cost of power per kilowatt, and slightly less energy sales forecasted created the need for a look at our rates. After significant discussion on when the energy rate (per kilowatt hour rate) may have to be increased, the board agreed with staff that most, if not all of the current upward cost pressures are directly related to our fixed charge. That "facilities charge" attempts to represent to you, the member, what it costs to provide electrical service to each and every one of you without regard to how much energy you are using. As of your April billing, received the first part of May 2024, you will see a \$1 increase in that charge. Without using more electricity this new year, this rate increase will cost you \$9 more in 2024 than in 2023.

Facility charge vs. kWh rate

What does each component accomplish?

Your residential electric bill has two major parts – a facility charge and an energy charge (kWh).



The facility charge is designed to cover the costs to deliver and maintain power to a service regardless of the amount of energy used. Fixed costs to deliver power to a service include poles, wires, transformers, meters, labor and other services associated with providing electric service.

The energy or kWh rate is based on power consumption. This rate is comprised of wholesale power costs, transmission, substation, environmental controls and capacity charges.

These mild temperatures are also favorable for potential ice storms and we sure hope that doesn't happen. I have both mowers going now clearing right of way. Our crews also completed rebuilding 3 miles of single-phase line southwest of Grygla. This line had copper-weld conductor that had been severely damaged by frosting and icing conditions. We have also started to rebuild 2 miles of twophase line in Stokes township. The crossarms and poles are in really tough shape. I also have plans to rebuild 2 miles of three-phase line northwest of Roseau. We will convert this line to heavy construction framing, with larger conductor that will be able to handle larger loads. We also have a dozen or more reject poles to change out in the Grygla area.

I would like to congratulate Steve Severson on his upcoming retirement! I have known and worked with Steve for many years and he will definitely be missed at this cooperative. He is a very knowledgeable individual in many areas, especially with metering and troubleshooting. I would also like to point out that he is one of the better fishermen that I know and I plan on fishing with him more in my retirement years. Way to go Steve – stay healthy and have fun!

I would like to wish everyone a Merry Christmas and happy and healthy New Year! I hope everyone gets to spend quality time with your friends and family during this wonderful time of the year, and let us not forget what Christmas is all about! 

2024 DIRECTOR ELECTIONS

PETITION DEADLINE TUESDAY, FEB. 6, 2024

Roseau Electric Cooperative, Inc., is organized as a cooperative and is owned by its members. The membership elects a board of directors to represent them in the operation of the cooperative.

Three directors will be elected at the 2024 Annual Meeting scheduled for April 6 at the Roseau School Theater. The directors whose terms expire in 2024 are: Jim Hallan, District 1 (3-year term); Ed Walsh, District 6 (3-year term); and Mark Sax, District 9 (3-year term). Jim Hallan has decided not to run for reelection.

NOMINATION BY PETITION

No nominating committee will be used. All nominations will be done by petition, including the incumbents.

Any 10 or more members who reside in Districts 1, 6 or 9 may nominate an eligible member for a director position in that district. No member may be elected to a director position unless nominated in this manner. No write-in ballots shall be accepted.

PETITION FORMS ARE AVAILABLE

Director candidates must pick up a petition and a director packet at Roseau Electric Cooperative, Inc., in Roseau. The packet contains additional forms that must be signed and turned in before the deadline.



PETITION DEADLINE

The cooperative must receive the completed petition no later than the close of business at 4:30 p.m. on Tuesday, Feb. 6, 2024.

VOICES FOR GRID RELIABILITY

America's electric grid is beginning to face significant reliability risks. As more baseload and dispatchable power plants are retired without adequate replacement, the margin for error is becoming razor thin.

Minnkota Power Cooperative, Roseau Electric Cooperative's wholesale power provider, maintains a diverse resource mix that includes coal, wind and hydro power that contribute to a reliable grid. However, the Minnkota system is connected with other utilities across the central United States – from North Dakota and Minnesota down through Louisiana. Challenges in other parts of the country can contribute to reliability issues in our region.

Regulators, policymakers, utilities and others are voicing their concerns about transitioning too quickly toward intermittent resources – like wind and solar – without retaining the stability provided by coal, nuclear and natural gas power plants. Here's what some of the major entities responsible for reliability are saying.

Federal Energy Regulatory Commission (FERC)



We are heading for potentially very dire consequences, potentially catastrophic consequences in the United States in terms of the reliability of our grid." – MARK CHRISTIE, FERC COMMISSIONER, AT A HOUSE ENERGY AND COMMERCE COMMITTEE, ENERGY SUBCOMMITTEE HEARING ON JUNE 13, 2023.

North American Electric Reliability Corporation (NERC)



... one of the important things that these plants provide is the ability for the grid to maintain voltage and maintain frequency and to resist disturbances. Other resources can't do that nearly as well as large spinning mass generation. Midcontinent Independent System Operator (MISO)

Minnkota Power Cooperative (MPC)
