

But, missing the rapture is not the same as losing all hope of salvation through the everlasting gospel. Time-wise, the "rapture" comes before the "harvest" which is the very end of the world. Mt. 13:24-49. This parable says that the unbelievers and believers are allowed to grow together, right up to the "harvest" at the end of the world. Rev. 7:9-14 tells of a great multitude who are saved out of the great tribulation, and Rev. 14:6 tells of the "everlasting gospel". So, as long as there is life, there is hope: including hope that those left after the rapture will receive the gift of Jesus and be forgiven and have eternal life, even though they experience tribulation as a consequence of their earlier denial.

If that happens, <u>it would be wonderful for the remnant to find that their Christian family or friends have by foresight and faith made provisions for them</u>. So their deep regrets will be soothed by their deep gratitude that even though they must endure great



tribulation, the Lord caused provisions to be put in place for them. And the plan you put in place will be your testimony of hope for a chance for your family and friends to be pardoned, like Simon Peter was.

Understanding: How Provision Delayed Is Provision Denied. If you are caught up in the rapture, you won't be dead, but you won't be found on earth, either. As for your assets, titles and legal affairs, your official legal status will be "missing". Your Last will and Testament, your life insurance, your beneficiary designations, and your pay on death accounts won't operate, because there will be no proof of your death. The law establishes when a missing person is presumed dead.

Generally, to illustrate the problem, when a person is missing without evidence, countries set a number of continuous years of absence before the person is declared dead,



to wit: Italy, 20; Germany 10; England, India, Ireland, and Scottland, 7; Poland, and Russia, 5; and in the United States, each state sets the time.² This presumption varies by state and can be four years up to seven years. Disappearing without proof of death creates a legal problem, but waiting for years is not a solution in the event of rapture.

Your loved ones would find that a delay of years in receiving provisions would be the same as being denied provisions. THE GOLDEN RULE LAW GROUP® wants to address that, and three other specific problems; (1) With a vast amount of assets suddenly unguarded, there could be a rush of adverse possession, fraudulent claims and confiscation of assets, in the absence of legally provable ownership. We want to help you avoid that. (2) Many normal estate planning documents such as trusts, wills and powers of attorney may have disinherited, limited, or denied authority over assets to family members who fell out of favor because of their current behavior or beliefs. This could tie all the assets up, and deny them financial assistance or a place to live at the worst time imaginable. We want to help you fix that. (3) Finally, if the laws on presumption of death are changed after the rapture, the results could be anyone's guess as to Christian estates. There is even a provision for that.

The solution we propose will seem worthless to people who do not expect a rapture. So, this solution is for people who recognize a problem because they expect the rapture and they assign value to having their affairs in order for that unique event if it happens during their lifetime.
