

RETURNING THE SPARKS, INC.
PHOTOGRAPH, FILM, VIDEO AND AUDIO CONSENT AND RELEASE

Returning the Sparks, Inc. (“RtS”) uses images and sounds of families and individuals promoting Jewish identity in support of its educational and charitable mission. RtS does not use a person’s likeness, or identify any person by name, unless it has received specific written permission to do so.

In consideration of the above, I hereby grant RtS and its partners in the Fly With Us competition (Jewish federations in New England, the Consulate General of Israel to New England, Israel’s Ministry of Tourism, Authentic Israel, Delta Airlines, IAC New England and Jookender) permission –

1.(1) to photograph, film, and make audio and/or video recordings of our family in the event that our entry receives a prize and 2. (2) to use and display the photograph(s), film(s), and audio and/or video recording(s) of our family and our likenesses, voices, and appearances, in whole or in part, in RtS’ and Fly With Us partners’ websites, archives, and promotional and/or informational materials (including, but not limited to the websites, newsletters, brochures, advertisements, and newspaper articles), and in any and all media, broadcast, or digital format, including electronic, radio, internet, and television, throughout the world.

If our family wins any prize through the Fly With Us competition, including the grand prize, I understand that it is the sole responsibility of our family to determine and pay any and all related taxes.

Additionally, if our family wins the grand prize, we agree to sign an affidavit of eligibility and publicity/liability release of a major prize and a publicity/liability release for each travel prize winner, which includes provisions that (1) grant Delta the right to use the name, likeness, voice, and biography of the winning adults and children for promotional purposes, and (2) release Delta and its affiliated companies from and against any and all liability arising from the use of the prize awarded to the winner or otherwise in connection with the Contest.
