Please take a moment to read the Conditions of Use along with other pertinent information below which will allow for a seamless transition between Pro Shop and you, our All Access Pass Weekday Holder.

1. 2024 CONDITIONS OF USE:

- All AAP-W Holders are to provide a valid credit card. All credit cards are stored electronically in our Moneris Vault for maximum security.
- At time of booking, payment is not required. We will, however, process your green fee to your credit card on file 24 hrs prior to your tee time. A receipt will be emailed to you once payment has been completed.
- AAP-W Holders must check-in with the Proshop prior to each round.
- AAP-W Holders can enjoy 14-day advance booking when booking online.
- Not valid on weekends or the following holidays (Monday, May 20; Monday, July 1; Monday, Aug 5; Monday, Sept 2; Monday, Oct 14, 2023).
- At time of booking, if the AAP-W Holder books a cart, payment for the cart will not be processed until the AAP-W Holder checks in at the Pro Shop and requests a cart key. It is only then that the cart will be charged to the account of the AAP-W Holder.
- AAP-W Holders playing in our Monday, Tuesday or Thursday evening leagues have the option of having their weekly league fees put on their AAP-W account.
- AAP-W Holders playing on weekends and/or holidays will pay the public rack rate green fee which will be applied to their credit card 24 hrs prior to the tee-time. A receipt will be emailed to you once payment has been completed.
- The AAP-W is non-transferable.

2. GUESTS OF APP-W HOLDERS:

- When guests are joining you for a round of golf, please inform them of the following policies at time of booking:
 - There are no discounts for Guests of AAP-W Holders
 - Prepayment is required prior to 24 hrs before time of play by calling the Pro Shop
 - Once inside 24 hours, any unpaid guests will be removed from the reserved tee-time and made available

3. CANCELLATION POLICY:

- Bear Creek recognizes cancellations are going to take place throughout the golf season for a variety of reasons.
 The following cancellation policy will be in effect for the 2024 golf season:
 - Cancellation 1 day prior to tee time will result in a credit being applied to your electronic profile (the value of the green fee booked – 9 or 18)
 - On your next booking, the amount of your credit will automatically be applied.
 - Cancellations made the day of play will result in no refund or rain check being issued.
