HIGHWAY – one truck was at Hunter with warning lights on; waiting on a hoist for another truck & changed the water pump on the Daewoo. Changed 3 pipes – 2 on Griswold & 1 on O'Connor at the 77 intersection. Did a 1" top on Bell Road, about ½ done with the second mowing. Rented a screen for millings, screened ditch dirt and millings to be able to use the good stuff. Generator guy is coming tomorrow morning.

ATTORNEY – working on the Franchise Agreement and Water District #11

ASSESSOR – computer is really slow; believe we can switch money from the Supervisor .2 to get a new one. ENGINEER – CPL is working on the sewer

Legislature Dibble gave an overview on the progress on the jail project – it's running on time and in budget, they will be starting the budget process very soon & will have negotiations with 2 unions for this budget; more money was just put into the grant writing grant, and we should check with Matt on the ceiling.

Mr. Dave Olsen wanted to find out if his property (just north of the sewer district) would be required to be included in the new sewer project or if he will still be able to use septic there. Supervisor Ferry stated that it is not required to connect because it is only going to be a transmission line only.

Mrs. Cindy Morrison asked about possibly having 2 turkeys carved to go under the Town of Darien sign and have the native name put on as well. Supervisor Ferry stated that there is nothing left in beautification, we've been trying to get grants for other things but to get amounts and sketch of what it would look like.
