
ANNUAL REPORT 2018



Dear Residents.

Many years ago "friends" of Jefferson's Ferry formed a Steering Committee to develop a philanthropy program in an effort to support the mission and vision of our Community. Those individuals had a passion for both philanthropy and their home at Jefferson's Ferry. Their efforts culminated into the creation of the Jefferson's Ferry Foundation, a New York non-profit, 501(c)(3) corporation.

For nearly fifteen years the efforts of the Foundation and its Board of Trustees have resulted in many notable contributions to life here at Jefferson's Ferry, including the annual Monte Carlo Night, the construction of the Community Center Porte Cochere, the spa program in the Vincent Bove Health Center, and the establishment of the Resident Assistance Fund, just to name a few.



The Jefferson's Ferry Board of Directors has agreed to assist the Foundation in this transition by assuming the administrative and other corporate functions of the Foundation, thereby enabling the Steering Committee to focus its efforts on grassroots fundraising campaigns and donor development.

The role of the Steering Committee and its members will be to actively participate in fundraising programs and events to support Jefferson's Ferry and to promote benevolence by enthusiastically engaging and enlightening residents, families and friends to the power and spirit of philanthropy.

In 2018, the Jefferson's Ferry Foundation raised \$104,635 towards the Resident Assistance Fund through the generosity of our donors.

The Foundation utilized over \$51,000 to support our residents in need. This fund is constantly being put to use each month.

Every donation counts, no matter how small. Our goal is to raise enough money for this fund so it can be self-sustainable.

PING PONG ANYONE?



For example: Mary wanted to make a \$5,000 gift to the Resident Assistance Fund to help her fellow neighbors. However, she wasn't in the position to give it all at once. Mary opted to make a pledge in the amount of \$5,000 over 5 years time. She will make one \$1,000 payment each year until she reaches \$5,000 in year five. Mary will be able to claim her gift of \$1,000 each year on her taxes AND get her name on our donor wall in the Community Center at the \$5,000 level.

Become a Contributor

Through the Jefferson's Ferry Foundation, there are many ways that you can contribute to making Jefferson's Ferry an even better place to live and work.

A gift to the general fund will allow for the Foundation to apply your gift to the area of greatest need.

The Resident Assistance Fund is an area of great importance to residents of Jefferson's Ferry. By making a gift to this fund, you will be providing financial assistance for residents of Jefferson's Ferry who have run out of money through no fault of their own.

Wellness is a combination of many aspects that strengthen and enhance the mind, body and spirit. A gift made to Health and Wellness Programming will support the entire human experience, encompassing the primary elements of a healthy lifestyle: emotional, intellectual, physical, social, spiritual, occupational and environmental wellbeing.

A gift made to the Employee Education and Assistance Fund provides staff with the opportunity to further pursue education in their field, reimbursement for textbooks and hardship loans in time of need. Often residents use this as a method of giving back to the staff for the care they were provided, as tips are not accepted at Jefferson's Ferry.

Gifts made to this fund will aid in various building projects such as expansions, improvements, and updates in technology.

Planned Giving Opportunities

The Jefferson's Ferry Foundation offers many great opportunities to leave your mark on Jefferson's Ferry

Charitable Gift Annuity

Retain income benefits from the assets you give to Jefferson's Ferry and thus afford a larger gift. When you create a charitable gift annuity or charitable remainder trust, you will receive income, a charitable deduction, and diversify your holdings. You can reduce high tax liability now while gaining additional income.

Entrance Fee Gift

The entrance fee for most residents can be pledged as an irrevocable gift to the Jefferson's Ferry Foundation. This may result in a substantial tax deduction for people that itemize on their tax return. For residents making this type of bequest, there may be significant tax planning opportunities with no out-of-pocket expense.

Partnership Interest

Avoid capital gains liability on the transfer of a business or partnership interest. You can contribute the partnership interest or closely-held stock to the Jefferson's Ferry Foundation. You will receive an income tax deduction for your gift.

Life Insurance

Create a new life insurance policy or donate a paid-up policy you no longer need. This will increase your ability to make a significant gift to Jefferson's Ferry.

Deferred Gift Annuity

Establish a deferred gift annuity and take a larger deduction at a higher income rate than other life-income gifts.


Real Estate Gift

Make a gift of real estate to the Jefferson's Ferry Foundation and avoid capital gains tax. Receive an income tax deduction and enjoy the option of a gift that doesn't affect your lifestyle.

Charitable Lead Trust

You can reduce gift and estate taxes and control the timing of passing assets to your children, grandchildren, and great-grandchildren. Create a charitable lead trust for a fixed, finite period with the principal going to your heirs. Reduce gift and estate taxes and freeze the taxable value of growing assets before they pass to your family.


DECEMBER 31, 2018 FOUNDATION FUND BALANCES
