ATTORNEY THOMAS MURNANE STATED WHERE WILL YOU STORE THE FIREWORKS?

NEIL SHAW STATED THERE WILL BE A STEEL BULDING TO STORE THE EXTRA FIREWORKS AND THERE WILL BE 24 HOUR SECURITY. I BELIEVE THE COUNTY CALLS THE LOCAL FIRE DEPARTMENT TO DO A INSPECTING

ON THE TENT.

JAY BOYEA STATED I BELIEVE OUR CODE OFFICER WILL INSPECT THE TENT.

ATTORNEY THOMAS MURNANE STATED THE APPLICANT HAS THE WRONG SEQR FORM FILLED OUT AND I DO HAVE SOME CONCERN WITH WERE THEY WILL BE STORING THE FIREWORKS.

NEIL SHAW STATED LAST MONTH THE BOARD DIDN'T SAY ANYTHING ABOUT THE WRONG FORM AND I DIDN'T THINK THERE WAS ANYTHING ELSE NEEDED WITH THE APPLICATION.

CHAIRPESON BRUCE SEGUIN STATED LAST MONTH OUR ATTORNEY WASN'T PRESENT AT THE MEETING SO WE DIDN'T REALIZE IT WAS THE WRONG SEQR FORM.

ATTORNEY THOMAS MURNANE STATED THE BOARD CAN NOT VOTE ON THE APPLICATION WITHOUT A CORRECT SEQR FORM.

DANIEL BECHARD STATED I DIDN'T REALIZE THE VINYL FENCING WAS GOING TO COST SO MUCH OR I WOULD NOT HAVE AGREED TO IT.
