1. Name of service being provided

Drogheda Motor Show

2. Nature of service and principles to safeguard children from harm

The Drogheda Motor Show is a collective exhibition of brand-new vehicles from a number of participating Drogheda based motor dealerships to the general public. This will be the 13th year running for the show, the fourth at this town centre venue. This year's show is based on the public display of approximately 80 new motor vehicles from 9 Drogheda Franchised Motor Dealerships, now covering 20 marques. The risk assessment is based on the risks associated with the Dealers exhibiting motor vehicles on Laurence Street on the 21st October 2023. While the show will have no direct interaction with children, Parents will be travelling with their children and we have assessed any risks associated with this.

3. Risk Assessment

We have carried out an assessment of any potential for harm to a child while availing of our services including the area of online safety when accessing the internet. Below is a list of the areas of risk identified and the list of procedures for managing these risks.

4. Procedures

- Procedure for maintaining a list of the persons (if any) in the relevant service who are mandated persons;
- Procedure for appointing a relevant person.

All procedures listed are available upon request.

5. Implementation

We recognise that implementation is an on-going process. Our service is committed to the implementation of this Child Safeguarding Statement and the procedures that support our intention to keep children safe from harm while availing of our service.

This Child Safeguarding Statement will be reviewed on 21/10/2023 , or as soon as practicable after there has been a material change in any matter to which the statement refers.
