### **Attachment functions**



#### Sapphire disk, coarse

Shortens thick nails easily and files nails. Be sure to use with caution: this attachment quickly removes large area of a nail.



#### Sapphire disk, fine

Files nails with precision and without the risk of burning the skin. The unique design only rotates the inner sapphire grinding disc, without movement of the external housing.



#### Sapphire milling cutter, round

For careful removal of corns — works layer by layer to prevent damage to healthy skin beneath it.



#### Cylinder milling cutter

Buffs rough surfaces as well as coarse smoothing of toenails. Place the cylindrical milling cutter horizontally on the nail surface and remove the coarse nail layer by moving the head in slow circles.



#### Needle milling cutter

The needle milling cutter is a precision tool for exposing ingrown nails and removing dead nail parts. Use this attachment at slow speed, since careless use can quickly cause injury.



#### Flame milling cutter

Grinds thick nails and removes ingrown nails. When treating ingrown nails, carefully position the flame milling cutter on the area to be treated & remove the desired nail parts.



#### Sapphire cone

Removes dry skin and calluses on the foot or heel. May also be used to trim the nail.



#### Attachment for using

the sandpaper rolls Rotating wheel for attaching sandpaper roll.



#### 10x Sandpaper rolls

Sandpaper rolls to remove dry skin and calluses from the sole, heel, and for filing nails.

10 pieces are included.



#### Felt cone

Buffs the surface of the nail after filing. Always use in circular movements to buff nails. Never allow cone to remain in one position for a prolonged time due to considerable amount of heat released.



## Sapphire cone, long and coarse

Removes hard skin and large calluses from the sole and heel. Do not remove hardened skin entirely to protect the healthy skin beneath. File until a thin layer remains then moisturize to soften the skin.



#### **Buff** holder

It used to hold the buff for continuous buffing and polishing the nails.



#### **Brown Buff**

Coarse-grit buff should not be used to buff the surface of the nails. They are meant only to shape nails from the side.



#### Green Buff

Fine-grit buff can be used to smooth ridges and surface irregularities. This can be done before applying nail polish or as a first step before finer buffing.



#### White Buff

Fine-grained buff is used to smooth the nail to a matte surface. The finest finishing grit gives the nails a glossy shine.



#### Protective cap for nail dust

Collects nail dust and residue during treatment sessions.

### Notes on handling batteries

- If your skin or eyes come into contact with fluid from a rechargeable battery cell, flush out the affected areas with water and seek medical assistance.
- Choking hazard! Small children may swallow and choke on batteries.
- Store batteries out of the reach of small children.
- Protect batteries from excessive heat.
- Risk of explosion! Never throw batteries into a fire.
- Do not disassemble, split or crush the batteries.
- Only use chargers specified in the instructions for use.
- Batteries must be charged correctly prior to use. The instructions from the manufacturer and the specifications in these instructions for use regarding correct charging must be observed at all times.
   Fully charge the battery prior to initial use.
- In order to achieve as long a battery service life as possible, fully charge the battery at least twice per year.

### **Instruction for Charging**

- Always ensure that your hands and USB charging cable are dry before charging.
- Make sure the device is powered off before charging.
- Connect the USB Type C plug to the USB Type C charging slot on the device.
- Connect the USB charging cable to the approved AC adaptor (not supplied) or USB port on a computer for charging the device.
- A full charge will last up to 4 hours.
- The LED will flash blue to indicate that the device is being charged.
- The LED will remain a steady blue color and will dim after 5 minutes when charging is complete.
- Unplug the AC adaptor or disconnect from the computer USB port after charging.
- The LED will flash during operation when the battery runs low.
- For the purposes of recharging the battery, only use the USB charging cable supplied with this device and charged by USB port on a computer or connect to a traditional wall mount approved AC adaptor (not supplied).

Make sure the device is fully charged before the first use. Do not charge inside bathroom or on any metal surfaces.

This appliance contains batteries that are nonreplaceable.

### **Instruction for Use**

**Short** press the ON/OFF switch to turn on the device; **Short** press the ON/OFF switch again to turn off the device;

1 Select the desired rotary direction by long pressing the ON/OFF switch after the device is powered on.

The LED lights up in GREEN For > clockwise rotation and lights up in RED For > counter clockwise rotation.

Remark: This bi-directional rotation feature is used for right or left handed operators for best performance

- 2 The front light will automatically switch on when the device is powered on.
- 3 Press the speed control button "+ / " to select the desired speed to start your treatment.
- 4 The Sleek operates at 5400 RPM. Most users will desire a slower speed. We recommend you begin your treatment on a low setting and then build speed as needed.
- 5 Usually, low speed is for finger or toe nails. High speed is for thick corn or dead skin.
- **6** The two buttons marked with (+) and (-) allow you to select the speed of rotation.
  - (+) button is increases the rotation speed;
  - (-) button is reduces the rotation speed.

- 7 When the LED indicator light double flashes in the speed selection, it indicates that the you have reached either the lowest or highest speed selection.
- 8 The device will memorize the last speed setting and rotation direction for the next use. It will auto reset when charging.
- **9** When the battery power is low, the LED indicator will blink to remind you to recharge the device. The Sleek requires 4 hours of charge time for a full charge.
- When the battery is completely exhausted the LED indicator will blink for 5 seconds and then will automatically shut off. A minimum charge time of 30 minutes is required for the device to function properly.

Tips: For better performance and results, do not wash your hands or feet before treatment. Wash after treatment and massage in a moisturizer to soothe your skin.



The device switches off automatically after 20 minutes. After this time, have a break of at least 15 minutes to prevent the motor from overheating.

The device switches off if an attachment is prevented from moving for approx. 3 seconds during use. To restart the device, switch it briefly off and then on again.

### **Lock Function**

The Sleek device can be locked in order to avoid it to power on accidentally.

- To LOCK: Press the ON/OFF switch for 5 seconds after the unit is switched off, until a blue LED will light up for 2 seconds.
   The unit will then be locked.
- To UNLOCK, press the ON/OFF button twice in 2 seconds. First
  press, and a RED LED will light up. Then press again and a GREEN
  LED will light up. The unit will then be unlocked for regular use.
- Or you can simply unlock it by charging the unit via the USB cable.

### **Diabetes User - Friendly Feature**

The unit comes with an over pressure stop sensor, which is specifically designed to protect you from hurting your skin or nails in case of careless over-pressuring the attachment. Once the auto-stop program is initiated, the front bright light will flash twice, and the LED indicator will flash RED. The device will then stop.

This feature is specifically designed for Diabetic users who may have low skin sensitivity.

### **DISPOSAL**

# PRODUCT CARE AND MAINTENANCE

Turn the unit off and unplug the power cord from the electrical outlet before cleaning the device.

Clean the device with a slightly moistened cloth.

You can also moisten the cloth with a mild detergent to remove stubborn stains.

Keep water out of the device.

If water does contact the device, let it dry thoroughly before using.

Clean the attachments with a cloth or brush moistened with alcohol; dry them carefully afterwards.

Do not use harsh chemicals or abrasive cleaners on the device.
