1. INTRODUCTION

The Promotion of Access to Information Act, Act 2 Of 2000 ("PAIA") gives effect to the constitutional right of access to any information held by the State and any information that is held by another person and that is required for the exercise or protection of any rights.

This is the Information Manual in Terms of Section 51 of PAIA in respect of Atterbury Property Group, which consist of Atterbury Property Holdings Proprietary Limited and the entities listed in Annexure A hereto ("Atterbury").

Atterbury is a property investment, development and holding group and regarded as a private body in terms of PAIA.

3. PURPOSE OF THIS MANUAL

- 3.1. This manual is a guide to accessing records held by Atterbury and is intended to provide guidelines to the members of the public who wish to exercise their constitutional rights embodied in PAIA.
- 3.2. This manual contains a guide in respect of how to lodge a request for information; the types of records that are available; grounds for refusal; what procedures will be followed in considering a request; the applicable fee structure; and information on the applicable appeal procedures should you not be satisfied with the outcome of the request.



4. THE PROTECTION OF PERSONAL INFORMATION ACT, NO. 4 OF 2013 ("POPI")

POPI amends PAIA in certain instances. Under POPI the South African Human Rights Commission's ("the **SAHRC**") functions in terms of PAIA will be transferred to the Information Regulator. The SAHRC will however still retain its constitutional obligation to promote, protect and monitor the right of access to information as rights enshrined in the Constitution of the Republic of South Africa.

5. DESCRIPTION OF THE GUIDE ON HOW TO USE PAIA PREPARED BY THE SAHRC ("THE GUIDE") AND THE MANNER IN OBTAINING ACCESS TO THE GUIDE (SECTION 51(1)(B) OF PAIA)

- 5.1. The SAHRC has compiled a guide in terms of section 10 of PAIA. The guide contains information required by any person wishing to exercise any right set out in PAIA.

- 6. CATEGORIES OF RECORDS OF ATTERBURY WHICH ARE AVAILABLE WITHOUT A PERSON HAVING TO REQUEST ACCESS IN TERMS OF PAIA (SECTION 51(91)(C) OF PAIA)
- 6.1. Records that are automatically available in terms of the Companies Act, No. 71 of 2008.
- 6.2. All information freely available on Atterbury's website, namely www.atterbury.co.za, are automatically available to any person requesting the information and it is therefore not necessary to apply for access thereto in terms of PAIA.

9. DETAIL ON HOW TO MAKE A REQUEST (SECTION 51(1)(E) OF PAIA)

- 9.1. The requester must comply with all the procedural requirements of PAIA relating to the request for access to a record.
- 9.2. The requester must complete Form C (available on the website of SAHRC) and submit this form together with a request fee to the Information Officer at the postal address, physical address or electronic mail address under Part 2 above.
- 9.3. The prescribed form must contain sufficient particularity in order to enable the Information Officer of Atterbury to identify –
 - the records requested;
 - the identity of the requester;
 - which form of access is required;
 - the postal address or electronic mail address of the requester in the Republic of South Africa.

9.4. In the prescribed form -

- the requester must identify the right that the requester is seeking to protect;
- the requester must provide an explanation of why the requested record is required for the exercise or protection of any right;
- if, in addition to a written reply, the requester wishes to be informed of the decision in respect of the request in any other manner, the requester must state the manner in which it wishes to be informed;
- if the request is made on behalf of another person, then the requester must submit proof of the capacity in terms of which the requester is making the request, to the reasonable satisfaction of the Information Officer of Atterbury.
- 9.5. Atterbury will inform the requester within 30 (thirty) business days after receipt of the request of its decision whether or not to grant the request.



- 9.6. The 30 (thirty) day period may be extended with a further period of not more than 30 (thirty) business days if the request is for a large number of records or requires Atterbury to search through a large volume of records or the records are not kept at the offices of Atterbury.
- 9.7. If the request for access is granted, the notice will state the access fee (if any) to be paid upon access, the form in which the access will be given and that the requester may lodge an application with a court against the access fee to be paid or the form of access granted, and the procedure for lodging the court application.
- 9.8. If the request for access is refused, the notice will state adequate reasons for the refusal, including the provisions of PAIA relied on and will state that the requester may lodge an application with a court against the refusal for the request, and the procedure (including the period) for lodging the application.

10. GROUNDS FOR REFUSAL OF ACCESS TO RECORDS (CHAPTER 4 OF PAIA)

Subject to sections 7 and 70 of PAIA, the main grounds on which Atterbury may refuse a request for information as contemplated in PAIA relate to the following:

- 10.1. mandatory protection of the privacy of a third party who is a natural person, which would involve the unreasonable disclosure of personal information of that natural person;
- 10.2. mandatory protection of commercial information of a third party, if the record contains
 - trade secrets of that third party;
 - financial, commercial, scientific, or technical information which disclosure could likely cause harm to the financial or commercial interests of that third party; and
 - information disclosed in confidence by a third party to Atterbury if the disclosure could put that third party at a disadvantage in negotiations or prejudice that third party in commercial competition.
- 10.3. mandatory protection of confidential information if the disclosure would constitute a breach of a duty or confidence to a third party in terms of any agreement;
- 10.4. mandatory protection of the safety of individuals and the protection of safety of property;
- 10.5. mandatory protection of records which would be regarded as privileged in legal proceedings;
- 10.6. the protection of the commercial activities of Atterbury which include -
 - trade secrets of Atterbury;
 - financial, commercial, scientific, or technical information which disclosure could likely cause harm to the financial or commercial interests of Atterbury.
 - information which, if disclosed, could put Atterbury at a disadvantage in negotiations or commercial competition;
 - a computer program which is owned by Atterbury, and which is protected by copyright
 except insofar as Atterbury is required to give access to a record to which access is
 granted in terms of PAIA; and



 research information of Atterbury or a third party on behalf of Atterbury, if the disclosure would expose the third party, Atterbury or the researcher of the subject matter of the research to serious disadvantage.

11. REMEDIES AVAILABLE ON REFUSAL OF A REQUEST FOR INFORMATION

- 11.1. Atterbury does not have an internal appeal procedure and as such, the decision made by the Information Officer of Atterbury is final.
- 11.2. If your request is denied, you are entitled to apply to a court with the appropriate jurisdiction for relief.
