



ADVOCATING FOR TEXAS TROOPERS, RANGERS, CID AGENTS, COMMUNICATION SPECIALISTS, AND FORENSIC SCIENTISTS

As a part of the Association's mission, DPSOA manages a number of important programs that impact Texas public safety personnel including: Survivor Death Benefits, Scholarships, Emergency Financial Assistance, and At-Risk Youth Programs. **Over the past nine years, DPSOA has contributed more than \$4.4 million to these important programs.**



DPS TROOPERS FOUNDATION

In 2010, the DPS Troopers Foundation (DPSTF) was granted 501(c)(3) status from the Internal Revenue Service. Donations to assist with scholarships, emergency financial assistance, at-risk youth programs and death benefits are now tax deductible. When tragedy strikes and a member is injured or killed in the line of duty, the DPSTF provides \$15,000 line of duty death benefit to the members beneficiary. All other member deaths receive \$5,000 death benefit. There is also a supplemental AD&D insurance policy that can add an additional \$23,750 in benefits.


Two recent examples of this are when a member was ambushed responding to an active shooter. The foundation raised over \$53,000 for he and his family while he recovered from his injuries. The AD&D policy paid an additional \$5,000 to him. When another member was killed in the line of duty the foundation raised over \$300,000 for the surviving family members.

DPSTF also has a Memorial Highway Campaign fund that raises money to erect signs in memory of a line of duty death. The original cost of the signs must come from private donations. Once erected, TxDOT maintains them for life.

DPSTF also awards over \$60,000 every academic year to members family who have dependents attending higher education. This is over twice as much as associations 5 times larger than DPSOA/DPSTF. The foundation also provides emergency financial assistance for member needs on a case-by-case basis and provides the Trooper "Teddy" that are given to children who have experienced trauma at an accident or crime scene.

DPSOA/DPSTF is a dues-based membership. The Board of Directors of DPSOA and Trustees with DPSTF are volunteers who do not earn a salary or commission. We do NOT use telemarketing.

REPRESENTATION AT THE LEGISLATURE

As a state agency, the Department of Public Safety depends on appropriations and legislation to fund and direct their law enforcement mandate. There is no better police union or other organization which negotiates better pay, better equipment and retirement for officers.

In fact, during the 2021 Legislative Session DPSOA leadership worked with legislators and other stakeholders to help secure more the \$118 million for a Schedule C pay raise — one of the largest pay increase in the history of the Department.

V LEGISLATIVE ACCOMPLISHMENTS

The Texas Legislature meets in Austin every two years for 140 days. DPSOA leadership works tirelessly during both the session and the interim to make sure the interests of Texas Public Safety personnel are protected. Legislative highlights during the past several legislative sessions include:

88TH SESSION | 2023

- Secured a pay increase.
- Secured funding for overtime pay, stipends, and health benefits
- Secured over \$750 million in funding to bring the Law Enforcement and Custodial Officer Supplemental (LECOS) Retirement Fund in actuarial soundness
- Secured additional funding of nearly \$2 billion to help bring the main Employees Retirement System (ERS) closer to actuarial soundness
- Helped pass legislation to rename 11 highways as memorials for troopers killed in the line of duty.

87TH SESSION | 2021

- Secured a pay increase for all commissioned officers and communication operators — \$118 million for the biennium.
- Secured funding for overtime pay and stipends
- » Raised the injury benefit for officers permanently disabled in the line of duty to be based on the maximum salary authorized under the officer's salary classification schedule (Schedule C) as prescribed by the General Appropriations Act
- Helped pass legislation to cover COVID-19 as a presumptive disease
- Secured funding to provide bullet resistant windshields for DPS patrol vehicles.
- Helped pass legislation to rename 12 highways as memorials for troopers killed in the line of duty.
- Secured funding to bring our ERS retirement fund into acturarial soundness with an ongoing commitment of funds in the state budget of approx. \$500 million per year above the state's regular pension contributions through fiscal year 2054.

86TH SESSION | 2019

- Secured funding for overtime pay and stipends
- Creation of the Peace Officer Loan Repayment Assistance Program
- Funding for human trafficking and anti-gang task forces

85TH SESSION | 2017

- Secured a change in the way overtime is accrued – instead of accruing the overtime in a work week (40 hrs) the overtime is accrued in a 24-hr period (anything over 8-hrs).
- Defeated attempts by some legislators to eliminate overtime pay and create new health insurance surcharges on ERS members in the 50-60 age group
- Protected retire-rehire employees from being terminated

84TH SESSION | 2015

Salary – Schedule C Salary Fix

83RD SESSION | 2013

>> Salary - 23% pay increase \$100 plus million

82ND SESSION | 2011

Dedicated funding source for LECOS — \$20 million per year

81ST SESSION | 2009

- Salary 9% pay increase \$23 million
- Communications and Forensic Scientist Reclassification — resulting in across the board pay increases — \$3.7 million
- » Retirees One-time payment \$500

80TH SESSION | 2007

- >> Salary \$6 million pay increase
- Increased Longevity (\$20 per year paid on two years) and Hazardous Duty Pay (\$10 per month per year) SB 1863

79TH SESSION | 2005

- Stipends Education, Certification and Bilingual
- Salary \$64 million pay increase, up to 23% for C3 positions
- Polygraph exam requirement for new troopers




